**SUBJECT:** Executive Summary of the Governor's Executive Orders Issued During COVID-19

### Summary

This memorandum provides an executive summary of the various Executive Orders issued during the declared disaster emergency related to COVID-19 in Colorado. The full text of the Governor's Executive Orders can be found here:

### Emergency Declaration

On March 10, 2020, Colorado Governor Jared Polis verbally declared a disaster emergency pursuant to the Colorado Disaster Emergency Act due to the presence of COVID-19 in the state. [Executive Order D 2020-003](#) memorialized this declaration a day later. A disaster emergency allows the Governor to activate authorities and resources that are unavailable in non-emergencies and specifically authorizes the administration to take steps, such as suspending certain statutes, rules, and regulations, to limit the spread of COVID-19.

## Executive Orders

Since the declaration of a disaster emergency, Governor Polis has issued approximately 370 executive orders in response to COVID-19. Executive orders typically expire after 30 days. Approximately 50 of the Governor's orders establish a directive or suspend statute, with the majority of the others extending or amending the initial orders. The executive orders are summarized by topic in alphabetical order below.

**Alternate care sites (expired March 2, 2021).** [Executive Order D 2020-071](#) allows the operation of alternate care sites across the state in the event COVID-19 overwhelms hospital resources. Extensions and related orders: [D 2020-107](#), [D 2020-137](#), [D 2020-163](#), [D 2020-189](#), [D 2020-218](#), [D 2020-244](#), [D 2020-275](#), [D 2021-006](#), [D 2021-034](#).

**Ballot petitions (expired August 10, 2020).** [Executive Orders D 2020-065](#) and [D 2020-103](#) authorized the Colorado Secretary of State to establish temporary rules to permit signature gathering for ballot initiatives by mail and email. The executive orders also suspended Colorado law that required signatures to be submitted within six months after ballot language is finalized and instead allowed signatures to be submitted by the deadline set in the constitution, which was August 3, 2020.

The Colorado Supreme Court, however, ruled that the Governor cannot suspend constitutional requirements by executive order, thereby requiring initiative proponents to gather signatures in person. In response, [Executive Order D 2020-128](#) deleted sections of the previous order concerning signature gathering, but left in the one regarding the August 3 deadline.

**Candidate petitions (expired July 28, 2020).** [Executive Order D 2020 053](#) extended the date that unaffiliated and independent candidates may begin collecting signatures. Extensions and related orders: [D 2020-085](#), [D 2020-119](#), [D 2020-148](#).

**Colorado Department of Public Health and Environment (CDPHE) reallocate existing funds from contracts with local public health agencies (expired March 25, 2021).** [Executive Order D 2020-066](#) authorized CDPHE to reallocate existing funds from contracts with local public health agencies for COVID-19 response activities, and permits the use of certain funds to conduct research to better serve minority and traditionally disadvantaged communities. [Executive Orders D 2020-293](#) redirects remaining state fund balances on Communities that Care-related contracts between CDPHE and local public health agencies for COVID-19 response activities. Extensions and related orders: [D 2021-026](#), [D 2021-050](#).

**COVID-19 dial framework.** [Executive Order D 2020-235](#) combines the Protect Our Neighbors, Safer at Home in the Vast, Great Outdoors, and Stay at Home directives into one framework called the dial. The framework puts each county into one of five dial levels based on the number of COVID-19 cases and hospitalizations, percentage of tests coming back positive, and whether these measures are improving or getting worse. Extensions and related orders: [D 2020-265](#), [D 2020-289](#), [D 2021-023](#), [D 2021-047](#), [D 2021-069](#) (in effect until 4/23/2021).

**Criminal justice.** [Executive Order D 2020-016](#) outlines ways in which to reduce and more easily manage the inmate population during COVID-19 and also addresses community corrections facilities, intensive supervision placement criteria, and county jail transfers. Extensions and related orders: [D 2020-043](#), [D 2020-078](#), [D 2020-112](#), [D 2020-140](#), [D 2020-166](#), [D 2020-192](#), [D 2020-221](#), [D 2020-248](#), [D 2020-278](#), [D 2021-012](#), [D 2021-039](#), [D 2021-060](#), [D 2021-082](#) (in effect until 5/6/2021).

**Department of Human Services federal funds (expired August 26, 2020).** [Executive Order D 2020-120](#) directed the Colorado Department of Human Services (CDHS) to access federal funds for child care services. [Executive Order D 2020-149](#) allowed the CDHS to access additional federal funds in order for counties to reimburse operating child care programs where enrollment is down as a result of the pandemic.

**Economic relief (expired January 25, 2021, but Disaster Emergency Funds remained available until February 28, 2021).** [Executive Order D 2020-230](#) provides a one-time payment of \$375 to Coloradans who earn less than \$52,000 a year and have filed for unemployment benefits during the COVID-19 pandemic. Extensions and related orders: [D 2020-262](#), [D 2020-287](#).

**Elections (expired January 21, 2021).** [Executive Orders D 2020-005](#) and [D 2020-008](#) direct the Secretary of State to amend rules to limit in-person contact during elections to allow the 2020 Primary Election to proceed without interruption. The Secretary of State was also authorized to adopt rules to provide necessary guidance for conducting elections during a public health emergency. Extensions and related orders: [D 2020-036](#), [D 2020-061](#), [D 2020-095](#), [D 2020-129](#), [D 2020-155](#), [D 2020-179](#), [D 2020-209](#), [D 2020-231](#), [D 2020-263](#), [D 2020-288](#).

[Executive Order D 2021-021](#) rescinded the previous election-related orders listed above. [House Bill 21-1001](#), enacted on January 20, 2021, authorizes remote participation in political party committee meetings and makes the election-related executive orders unnecessary.

**Evictions (expired October 22, 2020).** [Executive Order D 2020-101](#) required landlords to give 30 days notice to tenants who are late on their rent before initiating an eviction and clarified that tenants have the opportunity to cure any default for nonpayment. It also prohibited landlords and lenders from charging late fees or penalties due to nonpayment, but did not relieve an individual from their obligation to make mortgage or rent payments. Extensions and related orders: [D 2020-134](#), [D 2020-162](#), [D 2020-185](#), [D 2020-202](#).

**Evictions, foreclosures, and public utility disconnections and expediting unemployment insurance claim processing (expired June 13, 2020).** Executive Order [D 2020 012](#), among other things, imposed temporary limitations on evictions, foreclosures, and public utility disconnections. Extensions and related orders: [D 2020-031](#), [D 2020-051](#), [D 2020-088](#).

**Eviction moratorium (expired January 18, 2021).** [Executive Order D 2020-223](#) requires residential and commercial landlords to adhere to certain requirements before evicting tenants who have been economically harmed by COVID-19. [Executive Order D 2020-227](#) reinstates a state eviction moratorium and bans landlords from evicting tenants who can prove financial hardship from the pandemic. Extensions and related orders: [D 2020-255](#), [D 2020-285](#).

**Face coverings.** [Executive Order D 2020 039](#) requires that all workers at critical businesses wear a non-medical mask covering their nose and mouth while at work. Subsequent orders requires all Coloradans over the age of ten to wear non-medical grade face coverings in a "Public Indoor Space." Extensions and related orders: [D 2020-067](#), [D 2020-092](#), [D 2020 110](#), [D 2020 138](#), [D 2020-164](#), [D 2020-190](#), [D 2020-219](#), [D 2020-237](#), [D 2020-245](#), [D 2020-276](#), [D 2020-281](#), [D 2021-007](#), [D 2021-035](#), [D 2021-056](#), [D 2021-079](#) (in effect until 5/2/2021).

**Federal funds under the Coronavirus Aid, Relief, and Economic Security Act of 2020.** [Executive Order D 2020-070](#) directs the expenditure of the approximately \$1.67 billion the Colorado state government received from the federal CARES Act emergency COVID-19 funding from Congress. [Executive Order D 2020-081](#) broadens the allowable uses for this money. [Executive Order D 2020-216](#) increases and reallocates these funds to the Department of Corrections, Department of Human Services, food banks, housing programs, and state payrolls, among other areas. [Executive Order D 2020-295](#) allows unexpended CARES Act funds to be reallocated for reporting and monitoring purposes. [Executive Orders D 2020-294](#), [D 2021-027](#), [D 2021-051](#), and [D 2021-072](#) temporarily suspends certain deadlines so Corona Relief Fund dollars from the CARES Act may continue to be used.

**Food trucks at rest stops (expired September 26, 2020).** [Executive Order D 2020-056](#) allows food trucks to operate at Colorado's rest areas to support truckers and the movement of commercial vehicles. Extensions and related orders: [D 2020-090](#), [D 2020-122](#), [D 2020-151](#), [D 2020-174](#).

**Furloughs.** [Executive Order D 2020-203](#) orders most of Colorado's state government employees to take an unpaid furlough to help address the state's budget shortfall. The order applies to executive branch employees making more than \$50,000 a year and is tiered to lessen the impact on lower-wage employees and government services. Extensions and related orders: [D 2020-306](#) and [D 2021-078](#) (in effect until 6/30/21).

**Health care workforce.** [Executive Order D 2020-038](#) provides hospitals and other health care providers more flexibility to expand the trained medical personnel available to provide health care services within inpatient facilities. Extensions and related orders: [D 2020-063](#), [D 2020-097](#), [D 2020-131](#), [D 2020-158](#), [D 2020-182](#), [D 2020-212](#), [D 2020-240](#), [D 2020-271](#), [D 2021-002](#), [D 2021-008](#), [D 2021-036](#), [D 2021-057](#), [D 2021-080](#) (in effect until 5/4/2021).

**Home health workforce.** [Executive Order D 2020-077](#) provides protections for Colorado's Medicaid home health workforce, reduces the need for in-person visits, and eliminates cost-sharing for COVID-testing and treatment for Medicaid enrollees. Extensions and related orders: [D 2020-108](#), [D 2020-139](#), [D 2020-165](#), [D 2020-191](#), [D 2020-220](#), [D 2020-247](#), [D 2020-277](#), [D 2021-011](#), [D 2021-038](#), [D 2021-059](#), [D 2021-081](#) (in effect until 5/6/2021).

**Hospital and emergency room patient management (expired March 20, 2021).** [Executive Order D 2020-260](#) authorizes the CDPHE to order hospitals and freestanding emergency rooms to transfer or cease admission of patients should the facilities reach capacity. Extensions and related orders: [D 2020-286](#), [D 2021-020](#), [D 2021-046](#).

**Housing assistance (expired July 13, 2020).** [Executive Order D 2020-099](#) provided housing assistance and relief to Coloradans affected by COVID-19.

**Income tax.** [Executive Order D 2020-010](#) suspended the normal 2019 income tax payment deadline to July 15, 2020 due to the presence of COVID-19 in Colorado. Extensions and related orders: [D 2020-040](#), [D 2020-069](#), [D 2020-105](#).

Executive Order [D 2021-075](#) suspended the normal 2020 income tax payment deadline to May 17, 2021 due to the presence of COVID-19 in Colorado.

**Juvenile justice.** [Executive Order D 2020-034](#) suspends the authority given to the juvenile parole board and authorizes CDHS to assess whether a juvenile may be released to parole. The order also temporarily waives mental health facility requirements regarding patient visitation and clothing. Extensions and related orders: [D 2020-060](#), [D 2020-094](#), [D 2020-126](#), [D 2020-153](#), [D 2020-177](#), [D 2020-206](#), [D 2020-236](#), [D 2020-266](#), [D 2020-291](#), [D 2021-024](#), [D 2021-048](#), [D 2021-070](#) (in effect until 4/25/2021).

**Learning pods (expired March 4, 2021).** [Executive Order D 2020-188](#) facilitates home-based learning pods for Colorado students by temporarily suspending state child care licensure rules. Extensions and related orders: [D 2020-217](#), [D 2020-243](#), [D 2020-274](#), [D 2021-005](#), [D 2021-033](#).

**Local sales tax - extension for filing (expired June 4, 2020).** [Executive Order D 2020-023](#) provided a one-month extension for filing and remitting state and state-administered local sales tax and was extended for another 30 days by [D 2020-057](#).

**Marriage licenses.** [Executive Order D 2020-014](#) allows county clerk and recorder's offices that are closed due to COVID-19 to issue marriage licenses remotely. Extensions and related orders: [D 2020-028](#), [D 2020-048](#), [D 2020-083](#), [D 2020-117](#), [D 2020-146](#), [D 2020-172](#), [D 2020-200](#), [D 2020-228](#), [D 2020-256](#), [D 2020-282](#), [D 2021-017](#), [D 2021-043](#), [D 2021-066](#) (in effect 4/14/2021).

**Medicaid and CHP+ Eligibility.** [Executive Order D 2020-068](#) temporarily suspends certain statutes to maintain eligibility for Coloradans enrolled in Medicaid and the Children's Basic Health Plan. Extensions and related orders: [D 2020-104](#), [D 2020-136](#), [D 2020-160](#), [D 2020-183](#), [D 2020-214](#), [D 2020-241](#), [D 2020-272](#), [D 2021-003](#), [D 2021-031](#), [D 2021-054](#), [D 2021-076](#) (in effect until 4/29/2021).

**Notary (expired June 29, 2020).** [Executive Order D 2020-019](#) authorized remote online notarizations. Extensions and related orders: [D 2020-030](#), [D 2020-047](#), [D 2020-087](#).

**Nursing homes and other congregate care facilities - additional funds (expired April 6, 2021).** [Executive Orders D 2020-054](#), [D 2020-086](#), [D 2021-010](#), [D 2021-037](#), and [D 2021-058](#) directed the Colorado Department of Health Care Policy and Financing to provide additional funds to nursing homes and other congregate care facilities in response to COVID-19.

**Open burns (expired March 3, 2021).** [Executive Order D 2020-037](#) provides boards of county commissioners with broader discretion and greater flexibility to implement restrictions on open burning due to COVID-19. Extensions and related orders: [D 2020-062](#), [D 2020-096](#), [D 2020-130](#), [D 2020-156](#), [D 2020-180](#), [D 2020-210](#), [D 2020-238](#), and [D 2020-269](#).

**Protect our neighbors (replaced by [D 2020-235](#) on October 30, 2020).** [Executive Order D 2020-127](#) allows local communities to move from the requirements in the "Safer at Home in the Vast, Great Outdoors" order to the "Protect Our Neighbors" phase of the COVID-19 response. Extensions and related orders: [D 2020-154](#), [D 2020-178](#), [D 2020-207](#).

**Public utilities.** [Executive Order D 2020-098](#) provides relief to public utility customers to mitigate, respond to, and recover from the current economic disruption due to COVID-19. Extensions and related orders: [D 2020-132](#), [D 2020-157](#), [D 2020-181](#), [D 2020-211](#), [D 2020-239](#), [D 2020-270](#), [D 2021-001](#), [D 2021-030](#), [D 2021-053](#), [D 2021-074](#) (in effect until 4/28/2021).

**Safer at home (expired June 25, 2020).** [Executive Orders D 2020-044 and D 2020-079](#) permitted the limited reopening of certain business operations but continued the stay at home requirements for vulnerable individuals.

**Safer at home and in the vast, great outdoors (replaced by [D 2020-235](#) on October 30, 2020).** [Executive Order D 2020 091](#) transitions Safer at Home to Safer at Home in the Vast, Great Outdoors, which encourages individuals to enjoy Colorado’s outdoor spaces at a safe social distance in addition to staying at home as much as possible. Extensions and related orders: [D 2020-123](#), [D 2020-142](#), [D 2020-144](#), [D 2020-170](#), [D 2020-199](#), [D 2020-213](#).

**Sales tax (expired December 25, 2020).** [Executive Order D 2020-261](#) orders a one-month extension for remitting state sales taxes collected by qualifying restaurants and bars.

**Schools (expired June 21, 2020).** [Executive Order D 2020-007](#) suspended in-person instruction for all public, and private elementary and secondary schools, the Charter School Institute, and preschools on public campuses. Extensions and related orders: [D 2020-021](#), [D 2020-035](#), [D 2020-041](#), [D 2020-074](#).

**Signature collection for unaffiliated and independent candidates (expired September 10, 2020).** [Executive Order D 2020-064](#) temporarily suspended the statutory provisions requiring registered electors to sign petitions for unaffiliated and independent candidates in the presence of a petition circulator. It also authorized the Secretary of State to issue rules that allow for signature collection in a way that protects public health during COVID-19. Extensions and related orders: [D 2020-102](#), [D 2020-135](#), [D 2020-159](#).

**Ski resorts (expired May 30, 2020).** [Executive Order D 2020-004](#) required all Colorado ski resorts to close for one week. Extensions and related orders: [D 2020-006](#), [D 2020-026](#), [D 2020-049](#).

**Special legislative session.** [Executive Order D 2020-259](#) calls for a special legislative session focused on COVID-19 relief.

**State issued licenses.** [Executive Order D 2020-015](#) authorized the Executive Directors of certain state agencies to promulgate emergency rules extending the expiration date of over 100 different licenses, permits, registrations, designations, certifications, passes, authorizations, and endorsements, unless the renewal process may be completed online. Extensions and related orders: [D 2020-042](#), [D 2020-075](#), [D 2020-111](#), [D 2020-141](#), [D 2020-167](#), [D 2020-195](#), [D 2020-224](#), [D 2020-251](#), [D 2020-280](#), [D 2021-014](#), [D 2021-041](#), [D 2021-063](#), [D 2021-083](#) (in effect until 5/8/2021).

**State severance tax – one month extension for filing (expired May, 2020).** [Executive Orders D 2020-033](#) and [D 2020-059](#) extended deadlines for state severance taxes from April 15, 2020 until May 15, 2020.

**Stay at home (expired May 6, 2020).** [Executive Orders D 2020-017](#) and [D 2020-024](#) ordered Coloradans to stay at home due to COVID-19.

**Surgeries – limited (expired April 8, 2021).** [Executive Order D 2020-045](#) permits voluntary or elective surgeries to begin again under certain conditions. Extensions and related orders : [D 2020-080](#), [D 2020-114](#), [D 2020-145](#), [D 2020-169](#), [D 2020-198](#), [D 2020-225](#), [D 2020-249](#), [D 2020-279](#), [D 2021-013](#), [D 2021-040](#), [D 2021-062](#).



**Surgeries – temporary cessation (expired April 26, 2020).** [Executive Orders D 2020-009](#) and [D 2020-027](#) directed medical facilities to cease all elective and non-essential surgeries from March 23, 2020, until April 26, 2020.

**Suspension of programs and services due to insufficient revenues (expired June 30, 2020).** [Executive Order D 2020 050](#) restricted state spending for the current fiscal year ending June 30, 2020. The sequestration plan, as outlined in the order, reduced spending by \$228.7 million across 16 different state agencies to maintain the statutory reserve requirements in state law.

[Executive Order 2020-113](#) rescinded D 2020-050, because [House Bill 20-1360](#), also known as the Long Bill, replicated the order’s suspension or discontinuation of \$228.7 million in government programs through the end of Fiscal Year 2019-2020.

**Suspension of statutes.** [Executive Order D 2020-011](#) suspends statutes that prevent bars and restaurants from selling alcohol beverages for off-premises consumption, temporarily allows curbside delivery at marijuana dispensaries, and permits doctors to issue medical marijuana cards remotely. Subsequent related orders suspended and reinstated statutes regarding alcoholic beverage containers, gaming, sex offender registry, and vehicle weights. Extensions and related orders: [D 2020-029](#), [D 2020-052](#), [D 2020-084](#), [D 2020-093](#), [D 2020-118](#), [D 2020-147](#), [D 2020 173](#), [D 2020-201](#), [D 2020-229](#), [D 2020-257](#), [D 2020-283](#), [D 2021-018](#), [D 2021-044](#), [D 2021-067](#) (in effect until 4/14/2021).

**Taxable property (expired August 27, 2020).** [Executive Order D 2020-022](#) suspended calendar year 2020 taxpayer filing deadlines requirements for certain taxable property and directed Department of Local Affairs to issue emergency rules to extend filing deadlines. Extensions and related orders: [D 2020-055](#), [D 2020-089](#), [D 2020-121](#), [D 2020-150](#).

**Telehealth (expired July 27, 2020).** [Executive Order D 2020-020](#) expanded the use of telehealth services. Extensions and related orders: [D 2020-046](#), [D 2020-082](#), [D 2020-116](#).

**Tenants.** [Executive Order D 2020-307](#) imposes restrictions on charging fees or other penalties against a tenant or mobile home owner for failure to timely pay rent. Extensions and related orders: [D 2021-029](#) , [D 2021-052](#), [D 2021-073](#) (in effect until 4/29/2021).

**Unemployment insurance claims.** [Executive Order D 2020-100](#) orders \$1.0 million from the Disaster Emergency Fund continue to be available to improve and expedite services offered to individuals applying for unemployment insurance. Extensions and related orders: [D 2020-133](#), [D 2020 161](#), [D 2020 184](#), [D 2020-215](#), [D 2020-242](#), [D 2020-273](#), [D 2021-004](#), [D 2021-032](#), [D 2021-055](#) , [D 2021-077](#) (in effect until 4/29/2021).

**Vaccines.** [Executive Order D 2021-016](#) disallows co-payments or any fees associated with vaccine administration. Extensions and related orders: [D 2021-042](#) , [D 2021-065](#) (in effect until 4/13/2021).

**Veterinarians.** [Executive Order D 2020-292](#) expands the use of telehealth services for veterinarians. Extensions and related orders: [D 2021-025](#), [D 2021-049](#), [D 2021-071](#) (in effect until 4/25/2021).

**Wildfire emergency response fund (expired June 21, 2020).** [Executive Order D 2020-072](#) directed the transfer of \$763,000 from the Disaster Emergency Fund to the Wildfire Emergency Response Fund to support firefighting operations that have been strained due to challenges caused by COVID-19.

**Workforce in-person reduction (expired April 6, 2020).** [Executive Order D 2020-013](#) ordered all Colorado employers to reduce their in-person workforce by at least 50 percent beginning March 24, 2020, through April 10, 2020, while encouraging employers to implement telework, other work-from-home arrangements, staggered work schedules, or social distancing measures. This order was rescinded by [D 2020-025](#).
