- 17. Regarding Decision Item #1, the Document Imaging System, is this part of the e-mail consolidation initiative that has been requested by Department of Personnel?
- 18. Are pay day loan organizations regulated by the Division of Financial Services?
- 19. Regarding Decision Items #2 and #3, which request additional FTE, what will the time-lag be from when candidates are hired to getting them in the field? Where will the FTE be located Denver, a satellite location, elsewhere? Also, what will the impact be if these FTE

- 20. What are the Department's vacancy savings through December 31, 2006? How have vacancy savings been expended?
- 21. How can you add three cars to state fleet and have it be less expensive then using two? Who pays for gas and maintenance of car pool vehicles? Who pays for gas and maintenance of fleet vehicles within the departments? Does this request include additional funds to pay for the gas and maintenance of the requested vehicles? If not, how do these costs get billed to the department and how will the department pay for them?

Issue #1: Department of Regulatory Agencies Performance Measures

22. Regarding the Public Utilities Committee's meetings held throughout Colorado, does the PUC anticipate holding more of these meetings? Would holding 10 percent more meetings per year constitute an effective performance measure?

<u>Issue #2: Document Imaging System (DI #1)</u>

- 23. The decision item includes a request for 40 hours of consulting services as well as associated conversion consultant travel costs (estimated to be \$13,500). The Integrated Document Services (IDS) group, within the Department of Personnel and Administration, Division of Central Services possesses conversion services. Did the Department explore the possibility of utilizing IDS's conversion services in lieu of external consulting services? Please justify this request for these professional services.
- 24. Could the costs of the system be offset by revenue-generating opportunities such as providing document imaging assets to subscribers or online content sales?
- 25. What type of documents are converted to digital? Who, or what entities, would be interested in purchasing documents housed within the Document Imaging System? Does the department believe there is opportunity to cash fund this process? If so, how much revenue could be generated?

Issue #3: Office of Expedited Settlement Staffing Increase (DI #3)

26. What are the costs associated with those cases which are referred by the Office of Expedited Settlement (OES) to the Office of Attorney General (OAG) in terms of the overlapping costs of both the OES and the OAG when transferring the case from one office to the other?

- 27. With regards to cases seen both by the OES and OAG, what is the nature of these cases which give cause to the various boards first recommending the case to the OES, but which are ultimately referred to the OAG? Are there any measures the Department can take to assist the various boards with more effective case assignment procedures?
- 28. The Division of Registrations has witnessed an increase in the complexity of cases requiring legal services. Does the Division recognize any trends within the respective industries which may account for the increase in the complexity of cases, and thus increased legal services expenditures?
- 29. Are all cases referred to the Office of Expedited Settlement handled equally? Are there any cases which are given preference over other cases? If so, what criteria are used to prioritize the order in which cases are addressed? Would it be feasible to implement a risk-based approach to handling cases which are processed through the OES?
- 30. Why did the number of cases referred by the Office of Expedited Settlement to the Office of the Attorney General more than double from 20 to 48 between fiscal years 2004-05 and 2004-05?
- 31. Can the public search files for past experiences (actions taken against them) for a professional they are dealing with?
- 32. Did creation of OES result in a reduction in legal services to DORA? Did creation of OES slow the growth of legal services cost in the department? If so, can the department estimate by how much the growth was slowed?
- 33. Does the Department have a projection of anticipated cases in FY 2007-08?
