SUBJECT: JBC Member SMART Liaisons

DATE: January 7, 2015

Pursuant to the SMART act (Section 2-7-203 (3) (b), C.R.S.), the Chair of the JBC is required to assign one member of the JBC as a liaison for each department of state government. These liaisons work with the liaisons assigned by each joint committee of reference to inform the joint committee of reference regarding the department's performance management system and performance plan. The goal of this memorandum is to assist the Chair in beginning that process for the 2015 Session by providing a quick history of how the process has been handled for the past several years.

I have attached a copy of spreadsheet that contains the following columns:

- House Committees – This column reflects the various House committees of reference. *Please note that these potentially could change once the session begins based on actions of the House. The committees reflected on this spreadsheet are the committees that were established in rule during the 2014 Session.*
- Senate Committees – This column reflects the various Senate committees of reference. *Please note that these potentially could change once the session begins based on actions of the Senate. The committees reflected on this spreadsheet are the committees that were established in rule during the 2014 Session.*
- Departments – This column reflects the various departments that have been assigned to each committee of reference by rule. *This too could be changed in rule.*
- JBC Member Liaison – This column reflects the primary and backup members that the JBC Chair ultimately assigns as liaisons. In the past, the JBC has discussed the various assignments as a group, decided which members preferred which committees, established both a primary and a backup liaison for each committee, and then the JBC Chair appointed those individuals as liaisons. The JBC members appointed as liaisons to the various committees will be the liaison for the departments that are assigned to those committees of reference. Typically, the JBC member assigned as the primary liaison to a joint committee of reference leads the JBC member presentations to the joint committees of reference during the first month of the session in January.
- Ref Committee Liaison – This column contains the name of the various members that each Joint committee of reference assigns as their liaison. JBC staff fill-in this information as it becomes known.
