About This Report

This report provides information on the State Expenditure impacts of pending legislation at the 2025 legislative session using data from Legislative Council Staff Fiscal Notes. Expenditures are listed by General Fund, cash funds, federal funds, and centrally appropriated costs. FTE and TABOR refund impacts are also noted in this report.

The Summary Tab lists the total expenditure impact of pending bills by fiscal year. Expenditures for individual bills by fiscal year are shown on separate tabs. **NOTE:** Actual appropriations may differ from estimated expenditures. The data in this report documents the expenditure impacts and required resources to implement legislation, as estimated by LCS in fiscal notes. In situations where the General Assembly determines that no appropriation or a different appropriation is required than shown in the fiscal note, this data will continue to reflect the LCS fiscal note estimate. Please refer to the appropriation clause in the bill or the JBC Staff Appropriations Report for information/data on actual appropriations.
