HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB22-1159 be amended as follows:

1 Amend printed bill, page 6, strike lines 24 through 27.

2 Page 7, strike lines 1 through 5 and substitute:

3 "(d) IN ADMINISTERING THE CENTER, THE ADMINISTRATOR:

4 (I) SHALL SEEK AND CONSIDER THE INPUT OF:

5 (A) THE DEPARTMENT;

6 (B) THE OFFICE OF ECONOMIC DEVELOPMENT CREATED IN SECTION
7 24-48.5-101;

8 (C) REPRESENTATIVES FROM THE PUBLIC AND PRIVATE SECTORS
9 ENGAGED IN WASTE DIVERSION OR ECONOMIC DEVELOPMENT ACTIVITIES
10 ON THE WESTERN SLOPE, IN THE MOUNTAINS, ON THE FRONT RANGE, AND
11 IN EASTERN AND SOUTHEASTERN COLORADO; AND

12 (D) TO THE EXTENT PRACTICABLE, REPRESENTATIVES OF
13 NONPROFIT ORGANIZATIONS AND INSTITUTIONS OF HIGHER EDUCATION;
14 AND

15 (II) MAY SEEK AND SOLICIT ON BEHALF OF THE CENTER GIFTS,
16 GRANTS, AND DONATIONS TO PAY FOR THE FUNCTIONS OF THE CENTER, AS
17 DESCRIBED IN SUBSECTION (6) OF THIS SECTION."

18 Page 8, after line 8 insert:

19 "(6) **Gifts, grants, and donations.** THE CENTER MAY SEEK,
20 SOLICIT, ACCEPT, AND EXPEND GIFTS, GRANTS, AND DONATIONS FROM
21 PUBLIC AND PRIVATE SOURCES FOR THE PURPOSES OF THIS PART 6."

22 Page 8, strike line 10 and substitute "SEPTEMBER 1, 2030. BEFORE THE
23 REPEAL, THE FUNCTIONS OF THE CENTER ARE SCHEDULED FOR REVIEW IN
24 ACCORDANCE WITH SECTION 24-34-104."

25 Page 9, line 27, strike "and (5)".

26 Page 10, line 13, after "PAY" insert "UP TO FORTY PERCENT OF".

27 Page 10, strike lines 17 through 27.

28 Page 11, strike lines 1 and 2 and substitute:

29 "**SECTION 5.** In Colorado Revised Statutes, 25-16-104.5, **repeal**
30 (3.9)(c)(VII) and (6); and **add** (3.9)(d) as follows:

1 **25-16-104.5. Solid waste user fee - imposed - rate - legislative**
2 **declaration - repeal.** (3.9) (c) (VII) ~~This subsection (3.9)(c) is repealed,~~
3 ~~effective September 1, 2029.~~
4 (d) THIS SUBSECTION (3.9) IS REPEALED, EFFECTIVE SEPTEMBER 1,
5 2030.
6 (6) ~~This section is repealed, effective July 1, 2026.~~
7 **SECTION 6.** In Colorado Revised Statutes, 24-34-104, **add**
8 (31)(a)(VII) as follows:
9 **24-34-104. General assembly review of regulatory agencies**
10 **and functions for repeal, continuation, or reestablishment - legislative**
11 **declaration - repeal.** (31) (a) The following agencies, functions, or both,
12 are scheduled for repeal on September 1, 2030:
13 (VII) THE FUNCTIONS OF THE CIRCULAR ECONOMY DEVELOPMENT
14 CENTER CREATED IN SECTION 25-17-602."
