

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB22-1349 be amended as follows:

1 Amend printed bill page 6, line 5, after the period insert "THE
2 DEPARTMENT OF LABOR AND EMPLOYMENT, THE COLORADO WORKFORCE
3 DEVELOPMENT COUNCIL, AND THE DEPARTMENT OF EDUCATION SHALL
4 PROVIDE TO THE DEPARTMENT THE INFORMATION THAT THE DEPARTMENT
5 DEEMS NECESSARY TO IMPLEMENT AND OPERATE THE DATA SYSTEM."

6 Page 6, after line 5 insert:

7 "(c) THE DEPARTMENT MAY INCLUDE IN THE STATEWIDE DATA
8 SYSTEM EMPLOYMENT AND WAGE OUTCOME DATA OF A WORKFORCE
9 DEVELOPMENT OR TRAINING PROGRAM THAT JOINS THE DATA SYSTEM. IN
10 ORDER TO JOIN THE DATA SYSTEM, A WORKFORCE DEVELOPMENT OR
11 TRAINING PROGRAM MUST BE LISTED IN THE ELIGIBLE TRAINING PROVIDER
12 LISTS DESCRIBED IN SECTION 8-83-225 (1)(c) OR RECEIVING FUNDING
13 UNDER TITLE I OF THE FEDERAL "WORKFORCE INNOVATION AND
14 OPPORTUNITY ACT", 29 U.S.C. SEC. 3101 ET SEQ. THE DEPARTMENT MAY
15 PROVIDE A USER-FRIENDLY AND ACCESSIBLE OPTION FOR A PROGRAM
16 DESCRIBED IN THIS SUBSECTION (2)(c) TO DELIVER DATA TO THE
17 DEPARTMENT."

18 Reletter succeeding paragraphs accordingly.

19 Page 6, line 10, after the period, insert: "THE DEPARTMENT SHALL ALSO
20 SEEK INPUT FROM EACH INSTITUTION OF HIGHER EDUCATION, COLORADO
21 EMPLOYERS, COLORADO STUDENTS, AND OTHER WORKFORCE TRAINING
22 PROVIDERS OFFERING AN INDUSTRY RECOGNIZED CREDENTIAL."

23 Page 7, line 21, after "STATUS," insert "DISABILITY,".

24 Page 8, line 4, after "(5)" insert "(a)".

25 Page 8, line 10, after "STATUS," insert "DISABILITY, AGE,".

26 Page 8 after line 11 insert:

27 "(b) IN ORDER TO FURTHER THE GOAL OF USING DATA TO IMPROVE
28 INSTITUTIONAL DECISION-MAKING AND BEST PRACTICES, THE COMMISSION
29 SHALL FACILITATE INFORMATION SHARING AMONG INSTITUTIONS ABOUT
30 PRACTICES IMPLEMENTED BY AN INSTITUTION BASED ON DATA LEARNED
31 FROM THE DATA SYSTEM."
