Committee on Health & Insurance.

HB22-1399 be amended as follows:

1 Amend printed bill, page 2, strike lines 10 through 24 and substitute:
2 "SECTION 2. In Colorado Revised Statutes, **add** article 248 to
3 title 12 as follows:

4 **ARTICLE 248**

5 **Music Therapists**

6 **12-248-101. Definitions.** AS USED IN THIS ARTICLE 248, UNLESS
7 THE CONTEXT OTHERWISE REQUIRES:

8 (1) "MUSIC THERAPIST" MEANS A PERSON WHO HOLDS AN ACTIVE
9 MUSIC THERAPIST BOARD-CERTIFIED CREDENTIAL ADMINISTERED BY THE
10 CERTIFICATION BOARD FOR MUSIC THERAPISTS.

11 **12-248-102. Use of titles restricted - inspection.** (1) ON OR
12 AFTER THE EFFECTIVE DATE OF THIS ARTICLE 248, ONLY A PERSON WHO IS
13 A MUSIC THERAPIST MAY:

14 (a) CLAIM ORALLY OR IN WRITING TO BE A MUSIC THERAPIST OR A
15 BOARD-CERTIFIED MUSIC THERAPIST;

16 (b) USE THE TITLE "MUSIC THERAPIST" OR THE INITIALS "MT-BC";
17 OR

18 (c) USE ANY OTHER WORDS, LETTERS, ABBREVIATIONS, OR
19 INSIGNIA INDICATING OR IMPLYING THAT THE PERSON IS A MUSIC
20 THERAPIST.

21 (2) A PERSON WHO USES ANY OF THE TITLES, WORDS, LETTERS,
22 ABBREVIATIONS, OR INSIGNIA SPECIFIED IN SUBSECTION (1) OF THIS
23 SECTION SHALL MAKE AVAILABLE FOR IMMEDIATE INSPECTION BY ANY
24 CONSUMER OR AGENT OF THE STATE THE PERSON'S BOARD-CERTIFIED
25 CREDENTIAL ADMINISTERED BY THE CERTIFICATION BOARD FOR MUSIC
26 THERAPISTS.

27 **12-248-103. Scope of this article 248.** NOTHING IN THIS ARTICLE
28 248 PROHIBITS A PERSON FROM PERFORMING WORK, INCLUDING THE USE
29 OF MUSIC, INCIDENTAL TO THE PERSON'S PROFESSION OR OCCUPATION, IF
30 THE PERSON DOES NOT REPRESENT THAT THE PERSON IS A MUSIC
31 THERAPIST.

32 **12-248-104. Cease-and-desist orders.** THE DIRECTOR MAY ISSUE
33 CEASE-AND-DESIST ORDERS UNDER THE CIRCUMSTANCES AND IN
34 ACCORDANCE WITH THE PROCEDURES SPECIFIED IN SECTION 12-20-405.

35 **12-248-105. Unauthorized practice - penalties.** A PERSON WHO
36 VIOLATES SECTION 12-248-102 COMMITS A CLASS 2 MISDEMEANOR AND
37 SHALL BE PUNISHED AS PROVIDED IN SECTION 18-1.3-501."
