SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

SB22-213 be amended as follows:

- 1 Amend printed bill, page 8, line 3, after "**training**" insert "**and grant**".
- 2 Page 8, after line 7 insert:
 - 3 "(b) "ELIGIBLE ENTITY" MEANS A FAMILY, FRIEND, AND NEIGHBOR
 - 4 PROVIDER THAT IS ACTIVELY PROVIDING INFORMAL, LICENSE-EXEMPT
 - 5 CHILD CARE AND HAS COMPLETED TRAINING IN ONE OR MORE AREAS OF
 - 6 THE TRAINING AND GRANT PROGRAM CREATED IN SUBSECTION (3) OF THIS
 - 7 SECTION."
- 8 Reletter succeeding paragraphs accordingly.
- 9 Page 8, line 12, after "TRAINING" insert "AND GRANT".
- 10 Page 8, line 13, after "TRAINING" insert "AND GRANT".
- 11 Page 8, strike lines 23 and 24 and substitute:
 - 12 "(I) MEMBERS OF THE FFN EARLY CHILDHOOD WORKFORCE AND".
- 13 Page 9, line 2, strike "REPRESENTATIVES" and substitute "PARENTS OF
- 14 CHILDREN WHO RECEIVE CARE THROUGH FFN PROVIDERS,
- 15 REPRESENTATIVES".
- 16 Page 9, line 14, after "TRAINING" insert "AND GRANT".
- 17 Page 9, line 15, after "TRAINING" insert "AND GRANT".
- 18 Page 9, lines 18 and 19, strike "INFORMATION AND TRAINING" and
- 19 substitute "INFORMATION, TRAINING, AND GRANT FUNDING,".
- 20 Page 9, line 19, before "BEST" insert "FFN PROVIDERS WITH SKILLS AND
- 21 KNOWLEDGE ON CHILD DEVELOPMENT, SOCIAL AND EMOTIONAL
- 22 DEVELOPMENT, AND".
- 23 Page 10, line 2, strike "SPECIAL NEEDS;" and substitute "DEVELOPMENTAL,
- 24 EMOTIONAL, PHYSICAL, OR COGNITIVE DISABILITIES OR DELAYS;".
- 25 Page 10, after line 7 insert:
 - 26 "(b) THE DEPARTMENT SHALL PROVIDE COMMUNITY-BASED AND
 - 27 NONPROFIT ORGANIZATIONS WITH FUNDING TO OFFER GRANTS TO ELIGIBLE
 - 28 ENTITIES. THE DEPARTMENT SHALL CREATE A PROCESS FOR SOLICITING,
 - 29 VETTING, AWARDING, AND MONITORING GRANTS TO ELIGIBLE ENTITIES,

1 INCLUDING BUT NOT LIMITED TO CREATING A MECHANISM TO COLLECT
2 DEMOGRAPHIC INFORMATION REQUIRED FOR FEDERAL REPORTING. THE
3 MAXIMUM GRANT AWARD MUST NOT EXCEED NINE HUNDRED AND FIFTY
4 DOLLARS. ALLOWABLE USES FOR A GRANT INCLUDE:

- 5 (I) HEALTH AND SAFETY IMPROVEMENTS IN THE HOME;
- 6 (II) AGE-APPROPRIATE EDUCATIONAL MATERIALS;
- 7 (III) AGE-APPROPRIATE FURNITURE; AND
- 8 (IV) AGE-APPROPRIATE TOYS AND BOOKS."

9 Reletter succeeding paragraphs accordingly.

10 Page 10, line 10, before "PROCESSES;" insert "AND QUALIFIED EXEMPT".

11 Page 10, line 20, after "TRAINING" insert "AND GRANT".

12 Page 11, line 4, strike "FOUR" and substitute "SEVEN".
