HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB21-1040 be amended as follows:

- 1 Amend printed bill, page 2, line 3, strike "(2)(e) introductory portion,
2 (2)(e)(II), and (4)(a)" and substitute "(2)(e)(II) and (4)(a); and **add** (4.5)".
- 3 Page 2, strike lines 11 and 12 substitute "distribution of state funds that
4 are made available to:".
- 5 Page 2, lines 20 and 21, strike "EXCLUSIVELY FROM THE GENERAL FUND"
6 and substitute "AS SET FORTH IN SUBSECTION (4.5) OF THIS SECTION".
- 7 Page 2, strike lines 22 through 24 and substitute:
- 8 "obligations IMPOSED BY THIS SECTION, including fair compensation for
9 livestock losses that are authorized by this section; ~~but cannot be paid~~
10 ~~from moneys in the wildlife cash fund, imposed by this section;~~ and
11 (4.5) (a) FOR PURPOSES OF IMPLEMENTING AND ADMINISTERING
12 THIS SECTION, THE GENERAL ASSEMBLY SHALL APPROPRIATE MONEY TO
13 THE DIVISION FROM ONE OR MORE OF THE FOLLOWING FUNDS:
14 (I) THE GENERAL FUND;
15 (II) THE SPECIES CONSERVATION TRUST FUND CREATED IN SECTION
16 24-33-111 (2)(a);
17 (III) THE COLORADO NONGAME CONSERVATION AND WILDLIFE
18 RESTORATION CASH FUND CREATED IN SECTION 33-1-125; OR
19 (IV) THE WILDLIFE CASH FUND CREATED IN SECTION 33-1-112 (1);
20 EXCEPT THAT ANY MONEY WITHIN THE WILDLIFE CASH FUND THAT IS
21 GENERATED FROM THE SALE OF HUNTING AND FISHING LICENSES OR FROM
22 ASSOCIATED FEDERAL GRANTS IS NOT AVAILABLE FOR APPROPRIATION
23 UNDER THIS SECTION.
24 (b) THE LACK OF AN APPROPRIATION FROM THE GENERAL FUND
25 SHALL NOT HALT REINTRODUCTION OF GRAY WOLVES AS REQUIRED UNDER
26 SUBSECTION (2)(d) OF THIS SECTION.
27 (c) THE DIVISION MAY SOLICIT, ACCEPT, AND EXPEND ANY GRANTS,
28 GIFTS, SPONSORSHIPS, CONTRIBUTIONS, DONATIONS, AND BEQUESTS,
29 INCLUDING FEDERAL MONEY, FOR THE PURPOSE IMPLEMENTING AND
30 ADMINISTERING THIS SECTION."
