HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public & Behavioral Health & Human Services.

HB21-1030 be amended as follows:

1 Amend printed bill, page 3, line 22, after "AGENCIES," insert  
2 "BEHAVIORAL HEALTH ENTITIES, COUNTY OR DISTRICT PUBLIC HEALTH  
3 AGENCIES, COMMUNITY-BASED SOCIAL SERVICE AND BEHAVIORAL HEALTH  
4 PROVIDERS,".

5 Page 4, strike lines 12 through 16 and substitute:

6           "~~(a) On-scene response services to support peace officers'~~  
7 ~~handling of persons with mental health disorders~~ CO-RESPONDER  
8 COMMUNITY RESPONSES;

9           (b) COMMUNITY-BASED ALTERNATIVE RESPONSES;".

10 Page 4, line 17, strike "(b)" and substitute "~~(b)~~ (c)" and strike "OFFICERS,"  
11 and substitute "OFFICERS AND THEIR IMMEDIATE FAMILY MEMBERS,".

12 Page 4, line 20, strike "(c)" and substitute "~~(c)~~ (d)".

13 Page 4, line 23, strike "(d)" and substitute "~~(d)~~ (e)".

14 Page 4, line 26, strike "(e)" and substitute "~~(e)~~ (f)".

15 Page 5, line 8, strike "SERVICE PROVIDERS" and substitute "SOCIAL  
16 SERVICE OR BEHAVIORAL HEALTH PROVIDERS".

17 Page 5, line 25, strike "AND".

18 Page 6, line 2, strike "OF THIS SECTION AND A LAW" and substitute "OR  
19 (2)(b) OF THIS SECTION;".

20 Page 6, line 3, before "ENFORCEMENT" insert:

21           "(d) THAT A LAW".

22 Page 6, lines 4 and 5, strike "(2)(e) OF THIS SECTION." and substitute  
23 "(2)(f) OF THIS SECTION; AND".

24 Page 6, after line 5 insert:

25           "(e) THAT A BEHAVIORAL HEALTH ENTITY, COUNTY OR DISTRICT  
26 PUBLIC HEALTH AGENCY, OR COMMUNITY-BASED SOCIAL SERVICE OR  
27 BEHAVIORAL HEALTH PROVIDER MAY APPLY FOR A GRANT IN PARTNERSHIP  
28 WITH A LAW ENFORCEMENT AGENCY OR PUBLIC SAFETY AGENCY FOR THE  
29 PURPOSES OUTLINED IN SUBSECTION (2)(a) OR (2)(b) OF THIS SECTION."
