SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

SB21-040 be amended as follows:

1 Amend printed bill, page 4, strike lines 5 through 9 and substitute  
2 "REGISTRATION UNLESS:  
3 (a) THE EVENT IS RELEVANT TO THE ETHICS OF OR PERFORMANCE  
4 OF THE PROFESSION OR OCCUPATION THAT IS THE SUBJECT OF THE  
5 APPLICATION; AND  
6 (b) (I) THE OPERATION OF A MOTOR VEHICLE IS A DUTY OF THE  
7 PROFESSION OR OCCUPATION THAT IS THE SUBJECT OF THE APPLICATION;  
8 (II) THE EVENT IS A PART OF A PATTERN OF BEHAVIOR THAT IS  
9 RELEVANT TO THE ETHICS OF OR PERFORMANCE OF THE PROFESSION OR  
10 OCCUPATION THAT IS THE SUBJECT OF THE APPLICATION; OR  
11 (III) THE EVENT OCCURRED WITHIN THREE YEARS BEFORE THE  
12 DATE THAT THE APPLICANT SUBMITTED THE APPLICATION TO THE  
13 DEPARTMENT.  
14 (2)(a) UNLESS SUBSECTION (2)(b) OF THIS SECTION APPLIES, THE".

15 Page 4, line 10, strike the first "THE" and substitute "AN".

16 Page 4, strike lines 16 through 20 and substitute:

17 "(b) THE DEPARTMENT MAY CONSIDER AN EVENT WITHIN A  
18 DRIVER'S HISTORY IF:  
19 (I) THE EVENT IS RELEVANT TO THE ETHICS OF OR PERFORMANCE  
20 OF THE PROFESSION OR OCCUPATION FOR WHICH THE LICENSE HOLDER,  
21 PERMIT HOLDER, OR REGISTRANT IS LICENSED, PERMITTED, OR  
22 REGISTERED; AND  
23 (II) (A) THE OPERATION OF A MOTOR VEHICLE IS A DUTY OF THE  
24 PROFESSION OR OCCUPATION FOR WHICH THE LICENSE HOLDER, PERMIT  
25 HOLDER, OR REGISTRANT IS LICENSED, PERMITTED, OR REGISTERED;  
26 (B) THE EVENT IS A PART OF A PATTERN OF BEHAVIOR THAT IS  
27 RELEVANT TO THE ETHICS OF OR PERFORMANCE OF THE PROFESSION OR  
28 OCCUPATION FOR WHICH THE LICENSE HOLDER, PERMIT HOLDER, OR  
29 REGISTRANT IS LICENSED, PERMITTED, OR REGISTERED; OR  
30 (C) THE EVENT OCCURRED WITHIN THREE YEARS BEFORE THE ACT  
31 UPON WHICH THE DISCIPLINE IS BASED.".
