HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB21-1189 be amended as follows:

- 1 Amend printed bill, page 3, lines 14 and 15, strike "ENABLE FACILITIES TO
2 QUICKLY ADDRESS" and substitute "ADVISE FACILITIES OF".
- 3 Page 9, line 14, after the semicolon add "AND".
- 4 Page 9, strike lines 18 through 20 and substitute "SECTION."
- 5 Page 10, lines 4 and 5, strike "WITHIN TWO MONTHS AFTER SUBMISSION TO
6 THE DIVISION." and substitute "BEFORE THE DIVISION ACTS ON THE PLAN."
- 7 Page 10, line 19, after "SHALL" insert "PROMPTLY POST THE REVISED PLAN
8 ON THE DIVISION'S WEBSITE. IF THE INITIAL PLAN FAILED TO INCLUDE THE
9 REQUIRED ELEMENTS UNDER SUBSECTION (5)(b) OF THIS SECTION, THE
10 DIVISION SHALL".
- 11 Page 10, line 21, strike "PLAN." and substitute "PLAN, IN WHICH CASE THE
12 DEADLINE IN SUBSECTION (5)(e) OF THIS SECTION IS EXTENDED FOR
13 NINETY DAYS."
- 14 Page 10, line 22, after "(e)" insert "IF THE DIVISION DETERMINES THAT THE
15 COVERED FACILITY IS EMITTING HAZARDOUS AIR POLLUTANTS IN
16 QUANTITIES THAT MAY POSE A RISK TO PUBLIC HEALTH IN THE RELEVANT
17 AREA, THE DIVISION MAY REQUIRE AS PART OF THE PLAN THE REPORTING
18 OF POLLUTANTS OTHER THAN COVERED AIR TOXICS THAT THE MONITORS
19 ARE REASONABLY CAPABLE OF MEASURING."
- 20 Page 11, line 26, after "ANY" insert "HAZARDOUS AIR".
- 21 Page 11, line 27, strike "FENCELINE" and substitute "DIVISION
22 DETERMINED UNDER SUBSECTION (5)(e) OF THIS SECTION MUST BE
23 INCLUDED IN THE FENCELINE MONITORING PLAN; AND".
- 24 Page 12, strike line 1.
- 25 Page 13, line 16, strike "PROMPTLY".
- 26 Page 13, line 17, strike everything after "THE" and substitute "PUBLIC."
- 27 Page 13, strike lines 18 and 19.
- 28 Page 14, strike lines 1 through 5 and substitute "PLANS."

1 (c) THE COSTS OF CONDUCTING COMMUNITY-BASED MONITORING
2 SHALL BE PAID FROM FEES CREDITED TO THE AIR QUALITY ENTERPRISE
3 CASH FUND AS AUTHORIZED BY SECTION 25-7-103.5 (4)(b)(I).".
