SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB21-167 be amended as follows:

1 Amend printed bill, page 4, after line 16 insert:

2 "(III) THE DEPARTMENT SHALL REQUIRE AN ANNUAL INSPECTION
3 OF PLAYGROUND FACILITIES ON THE PROPERTY WHERE A CHILD CARE
4 CENTER OPERATES BY A NATIONAL PLAYGROUND SAFETY CERTIFICATION
5 EXPERT. FOR PURPOSES OF A PLAYGROUND FACILITY INSPECTION, THE
6 DEPARTMENT SHALL ACCEPT AS SATISFACTORY PROOF OF VALID
7 CERTIFICATION OF THE PLAYGROUND FACILITY, CERTIFICATION, OR A COPY
8 OF CERTIFICATION, FROM AN INDIVIDUAL WHO IS LICENSED OR CERTIFIED
9 TO PERFORM PLAYGROUND SAFETY INSPECTIONS THROUGH THE NATIONAL
10 RECREATION AND PARK ASSOCIATION, OR OTHER NATIONALLY
11 RECOGNIZED PLAYGROUND FACILITY SAFETY ORGANIZATION. THE
12 DEPARTMENT SHALL NOT REQUIRE A DUPLICATE INSPECTION IF A
13 SATISFACTORY INSPECTION REPORT WAS COMPLETED WITHIN THE
14 PRECEDING TWELVE MONTHS."

15 Page 4, strike lines 23 through 27.

16 Page 5, strike lines 1 through 8 and substitute:

17 "(b) THE STATE BOARD SHALL PRESCRIBE STANDARDS BY RULE FOR
18 PROGRAMS THAT OPERATE ON SCHOOL PROPERTY THAT WHEN AN AGENCY
19 OR ENTITY PERFORMS ANY INSPECTION REQUIRED BY LAW, THE AGENCY OR
20 ENTITY SHALL ALSO PROVIDE A COPY OF THE INSPECTION REPORT TO THE
21 APPROPRIATE OFFICIAL OF THE SCHOOL DISTRICT, DISTRICT CHARTER
22 SCHOOL, OR INSTITUTION CHARTER SCHOOL WHERE THE CHILD CARE
23 CENTER OPERATES."
