SB21-199 be amended as follows:

1 Amend printed bill, page 5, line 9, before "NOTWITHSTANDING" insert
2 "(1)".

3 Page 5, after line 11 insert:

4 "(2) PURSUANT TO SUBSECTION (1) OF THIS SECTION, VERIFICATION
5 OF LAWFUL PRESENCE IS NOT A REQUIREMENT FOR ANY STATE OR LOCAL
6 PUBLIC BENEFIT, INCLUDING BUT NOT LIMITED TO:

7 (a) FOR ANY PURPOSE FOR WHICH LAWFUL PRESENCE IN THE
8 UNITED STATES IS NOT REQUIRED BY LAW, ORDINANCE, OR RULE;

9 (b) FOR OBTAINING HEALTH-CARE ITEMS AND SERVICES THAT ARE
10 NECESSARY FOR THE TREATMENT OF AN EMERGENCY MEDICAL CONDITION
11 OF THE PERSON INVOLVED AND ARE NOT RELATED TO AN ORGAN
12 TRANSPLANT PROCEDURE;

13 (c) FOR SHORT-TERM, NONCASH, IN-KIND EMERGENCY DISASTER
14 RELIEF;

15 (d) FOR PUBLIC HEALTH ASSISTANCE FOR IMMUNIZATIONS WITH
16 RESPECT TO IMMUNIZABLE DISEASES AND FOR TESTING AND TREATMENT
17 OF SYMPTOMS OF COMMUNICABLE DISEASES, WHETHER OR NOT SUCH
18 SYMPTOMS ARE CAUSED BY A COMMUNICABLE DISEASE;

19 (e) FOR PROGRAMS, SERVICES, OR ASSISTANCE, SUCH AS SOUP
20 KITCHENS, CRISIS COUNSELING AND INTERVENTION, AND SHORT-TERM
21 SHELTER, SPECIFIED BY FEDERAL LAW OR REGULATION THAT:

22 (I) DELIVER IN-KIND SERVICES AT THE COMMUNITY LEVEL,
23 INCLUDING SERVICES THROUGH PUBLIC OR PRIVATE NONPROFIT AGENCIES;

24 (II) DO NOT CONDITION THE PROVISION OF ASSISTANCE, THE
25 AMOUNT OF ASSISTANCE PROVIDED, OR THE COST OF ASSISTANCE
26 PROVIDED ON THE INDIVIDUAL RECIPIENT'S INCOME OR RESOURCES; AND

27 (III) ARE NECESSARY FOR THE PROTECTION OF LIFE OR SAFETY;

28 (f) FOR PREGNANT WOMEN;

29 (g) FOR INDIVIDUALS EIGHTEEN YEARS OF AGE OR OLDER BUT
30 UNDER NINETEEN YEARS OF AGE WHO CONTINUE TO BE ELIGIBLE FOR
31 MEDICAL ASSISTANCE PROGRAMS AFTER THEIR EIGHTEENTH BIRTHDAY;

32 (h) FOR RECEIPT OF EDUCATIONAL SERVICES OR BENEFITS FROM
33 INSTITUTIONS OF HIGHER EDUCATION, EXCEPT AS MAY BE LIMITED
34 PURSUANT TO SECTION 23-7-110, INCLUDING PARTICIPATION IN THE
35 COLLEGE OPPORTUNITY FUND PROGRAM PURSUANT TO PART 2 OF ARTICLE
36 18 OF TITLE 23, COLLEGE SAVINGS PLANS PURSUANT TO PART 3 OF ARTICLE
37 3.1 OF TITLE 23, STATE STUDENT FINANCIAL ASSISTANCE PURSUANT TO
38 ARTICLE 3.3 OF TITLE 23, AND ANY OTHER FINANCIAL BENEFIT OF THE
39 INSTITUTION OF HIGHER EDUCATION RELATING TO ATTENDANCE AT THE

1 INSTITUTION OF HIGHER EDUCATION;
2 (i) UNLESS OTHERWISE REQUIRED BY FEDERAL LAW, FOR RECEIPT
3 OF PUBLIC OR ASSISTED HOUSING, HOUSING SERVICES, HOUSING
4 ASSISTANCE, OR OTHER SIMILAR BENEFIT; AND
5 (j) FOR AN APPLICANT FOR A LICENSE, CERTIFICATE, OR
6 REGISTRATION TO PRACTICE A REGULATED PROFESSION OR OCCUPATION,
7 INCLUDING AN APPLICANT SEEKING LICENSURE AS A CHILD CARE CENTER,
8 CHILD CARE PROVIDER, CHILDREN'S RESIDENT CAMP, FAMILY CHILD CARE
9 HOME, GUEST CHILD CARE FACILITY, NEIGHBORHOOD YOUTH
10 ORGANIZATION, SUBSTITUTE CHILD CARE PROVIDER, OR SUBSTITUTE
11 PLACEMENT AGENCY, AS THOSE TERMS ARE DEFINED IN SECTION 26-6-102.
12 (3) SUBSECTION (2)(j) OF THIS SECTION IS A STATE LAW WITHIN
13 THE MEANING OF 8 U.S.C. SEC. 1621 (d), AS THAT SECTION EXISTED ON
14 JANUARY 1, 2021."
