Committee on Judiciary.

HB21-1211 be amended as follows:

- 1 Amend proposed committee amendment (HB1211_L.001), page 2, strike
2 lines 17 through 21 and substitute:
3 "(1) "INTELLECTUAL OR DEVELOPMENTAL DISABILITY" MEANS A
4 DISABILITY ATTRIBUTABLE TO AN INTELLECTUAL OR DEVELOPMENTAL
5 CONDITION, AS DEFINED IN THE LATEST EDITION OF THE DIAGNOSTIC AND
6 STATISTICAL MANUAL OF THE AMERICAN PSYCHIATRIC ASSOCIATION, OR
7 RELATED CONDITIONS CONSTITUTING A SEVERE OR PROFOUND
8 DISABILITY."
- 9 Page 2, after line 24, insert:
10 "(3) "MEDICAL PROFESSIONAL" MEANS A REGISTERED NURSE
11 REGISTERED PURSUANT TO SECTION 12-255-111, A PHYSICIAN ASSISTANT
12 LICENSED PURSUANT TO SECTION 12-240-113, OR A MEDICAL DOCTOR OR
13 DOCTOR OF OSTEOPATHY LICENSED PURSUANT TO ARTICLE 240 OF TITLE
14 12.
15 (4) "MENTAL HEALTH PROFESSIONAL" MEANS A MENTAL HEALTH
16 PROFESSIONAL LICENSED OR CERTIFIED PURSUANT TO ARTICLE 245 OF
17 TITLE 12, EXCEPT IT DOES NOT INCLUDE UNLICENSED PSYCHOTHERAPISTS
18 PURSUANT TO ARTICLE 245 OF TITLE 12; AN ADVANCED PRACTICE
19 REGISTERED NURSE REGISTERED PURSUANT TO SECTION 12-255-111 WITH
20 TRAINING IN SUBSTANCE USE DISORDERS OR MENTAL HEALTH; OR A
21 PHYSICIAN ASSISTANT LICENSED PURSUANT TO SECTION 12-240-113 WITH
22 SPECIFIC TRAINING IN SUBSTANCE USE DISORDERS OR MENTAL HEALTH."
- 23 Renumber succeeding subsections accordingly.
- 24 Page 3, line 19, strike "AND" and substitute "OR".
- 25 Page 4, line 20, strike "FACE-TO-FACE," and substitute "FACE-TO-FACE OR
26 THROUGH A WINDOW,".
- 27 Page 6, line 4, strike "TIME," and substitute "TIME IN A TWENTY-FOUR-
28 HOUR PERIOD OF TIME,".
- 29 Page 6, line 41, strike "HEALTH STAFF IF PROBLEMS" and substitute "A
30 MEDICAL OR MENTAL HEALTH PROFESSIONAL IF INDICATIONS OF A
31 POSITIVE SCREEN".
- 32 Page 7, strike line 32.
- 33 Renumber succeeding subparagraph accordingly.
