HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB21-013 be amended as follows:

1 Amend reengrossed bill, page 2, line 5, strike "**legislative**" and substitute  
2 "**report - legislative**".

3 Page 5, after line 8, insert:

4       "(3) THE DEPARTMENT SHALL CREATE A REPORT SPECIFYING THE  
5 PURPOSES FOR WHICH THE DEPARTMENT USED THE FEDERAL MONEY  
6 RECEIVED PURSUANT TO THE FEDERAL "CORONAVIRUS AID, RELIEF AND  
7 ECONOMIC SECURITY ACT", PUB.L.116-136; THE "CORONAVIRUS  
8 RESPONSE AND RELIEF SUPPLEMENTAL APPROPRIATIONS ACT, 2021",  
9 PUB.L.116-260; AND THE "AMERICAN RESCUE PLAN ACT OF 2021",  
10 PUB.L.117-2. AT A MINIMUM, THE REPORT MUST IDENTIFY THE TOTAL  
11 AMOUNT THAT THE DEPARTMENT RECEIVED AND WAS AUTHORIZED TO  
12 SPEND AT THE STATE LEVEL UNDER EACH ACT, THE PURPOSES FOR WHICH  
13 THE DEPARTMENT SPENT THE AMOUNTS RECEIVED, THE SPECIFIC AMOUNT  
14 ALLOTTED TO EACH PURPOSE, AND ANY DATA THE DEPARTMENT MAY  
15 HAVE CONCERNING THE RESULTS ACHIEVED IN USING THE MONEY FOR  
16 EACH PURPOSE. ON OR BEFORE DECEMBER 1, 2021, AND ON OR BEFORE  
17 DECEMBER 1 EACH YEAR THEREAFTER THROUGH DECEMBER 1, 2024, THE  
18 DEPARTMENT SHALL SUBMIT THE REPORT TO THE EDUCATION COMMITTEES  
19 OF THE HOUSE OF REPRESENTATIVES AND SENATE, OR ANY SUCCESSOR  
20 COMMITTEES, AND POST THE REPORT ON THE DEPARTMENT'S WEBSITE. THE  
21 DEPARTMENT SHALL ALSO PRESENT THE REPORT AS PART OF THE  
22 DEPARTMENT'S HEARING HELD EACH JANUARY PURSUANT TO SECTION  
23 2-7-203, STARTING IN 2022 AND CONTINUING THROUGH 2025."
