SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB21-260 be amended as follows:

1 Amend printed bill, page 39, after line 9 insert:

2 **"24-38.5-304. Repeal of part - transfer of money to highway**

3 **users tax fund.** (1) THIS PART 3 IS REPEALED, EFFECTIVE JULY 1, 2032.

4 (2) ON JUNE 30, 2032, THE STATE TREASURER SHALL TRANSFER
5 ALL UNEXPENDED AND UNENCUMBERED MONEY IN THE COMMUNITY
6 ACCESS ENTERPRISE FUND CREATED IN SECTION 24-38.5-303 (5)(a) TO THE
7 HIGHWAYS USERS TAX FUND CREATED IN SECTION 43-4-201 (1)(a).".

8 Page 75, after line 10 insert:

9 **"25-7.5-104. Repeal of article - transfer of money to highway**
10 **users tax fund.** (1) THIS ARTICLE 7.5 IS REPEALED, EFFECTIVE JULY 1,
11 2032.

12 (2) ON JUNE 30, 2032, THE STATE TREASURER SHALL TRANSFER
13 ALL UNEXPENDED AND UNENCUMBERED MONEY IN THE CLEAN FLEET
14 ENTERPRISE FUND CREATED IN SECTION 25-7.5-103 (5)(a) TO THE
15 HIGHWAY USERS TAX FUND CREATED IN SECTION 43-4-201 (1)(a).".

16 Page 102, lines 7 and 8, strike "(25)(a.7) AND" and substitute "(25)(a.7)".

17 Page 102, line 10, strike "43-4-217 (8)" and substitute "43-4-217 (8), AND
18 MONEY THAT IS CREDITED TO THE HIGHWAY USERS TAX FUND AS
19 REQUIRED BY SECTIONS 24-38.5-304 (2), 25-7.5-104 (2), 43-4-1204 (2),
20 AND 43-4-1304 (2)".

21 Page 179, after line 5 insert:

22 **"43-4-1204. Repeal of part - transfer of money to highway**
23 **users tax fund.** (1) THIS PART 12 IS REPEALED, EFFECTIVE JULY 1, 2032.

24 (2) ON JUNE 30, 2032, THE STATE TREASURER SHALL TRANSFER
25 ALL UNEXPENDED AND UNENCUMBERED MONEY IN THE CLEAN TRANSIT
26 ENTERPRISE FUND CREATED IN SECTION 43-4-1203 (5)(a) TO THE
27 HIGHWAYS USERS TAX FUND CREATED IN SECTION 43-4-201 (1)(a).".

28 Page 196, after line 27 insert:

29 **"43-4-1304. Repeal of part - transfer of money to highway**
30 **users tax fund.** (1) THIS PART 13 IS REPEALED, EFFECTIVE JULY 1, 2032.

31 (2) ON JUNE 30, 2032, THE STATE TREASURER SHALL TRANSFER
32 ALL UNEXPENDED AND UNENCUMBERED MONEY IN THE NONATTAINMENT
33 AREA AIR POLLUTION MITIGATION ENTERPRISE FUND CREATED IN SECTION
34 43-4-1303 (5)(a) TO THE HIGHWAY USERS TAX FUND CREATED IN SECTION
35 43-4-201 (1)(a).".
