HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs & Labor.

HB21-1283 be amended as follows:

1 Amend printed bill, page 3, line 4, strike "(3)(a)," and substitute "(3),  
2 (4)(c), (5)(a)," and after "(2.5)" insert "and (4)(d)".

4 Page 4, line 6, strike "ELEVEN" and substitute "FOURTEEN".

5 Page 4, strike lines 11 and 12 and substitute:

6 "(III) ONE MEMBER APPOINTED BY THE GOVERNOR TO REPRESENT  
7 A TOWING ASSOCIATION WITHIN THE STATE WITH EXPERIENCE IN  
8 CONSENSUAL TOWING;

9 (IV) ONE MEMBER APPOINTED BY THE GOVERNOR TO REPRESENT  
10 NONCONSENSUAL TOWING CARRIERS;"

11 Renumber succeeding subparagraphs accordingly.

12 Page 4, strike lines 15 and 16 and substitute:

13 "(VI) ONE MEMBER APPOINTED BY THE GOVERNOR TO REPRESENT  
14 AN ASSOCIATION OF MOTOR CARRIERS WITHIN COLORADO AS CONSUMERS  
15 OF TOWING SERVICES;

16 (VII) ONE MEMBER APPOINTED BY THE ATTORNEY GENERAL WITH  
17 EXPERIENCE ENFORCING THE "COLORADO CONSUMER PROTECTION ACT",  
18 ARTICLE 1 OF TITLE 6;

19 (VIII) ONE MEMBER APPOINTED BY THE GOVERNOR TO REPRESENT  
20 PEOPLE WITH DISABILITIES;"

21 Renumber succeeding subparagraphs accordingly.

22 Page 5, line 15, strike "(2.5)(a)(V)" and substitute "(2.5)(a)(VII)".

23 Page 5, after line 16 insert:

24 "(b) The members shall elect a chair from among their  
25 membership. The chair shall set the times and frequency of the task  
26 force's meetings; EXCEPT THAT THE TASK FORCE SHALL MEET NO FEWER  
27 THAN TWO TIMES PER YEAR.

28 (4) (c) The commission ~~need not~~ SHALL accept AND IMPLEMENT  
29 the recommendations of the task force.

30 (d) (I) BY DECEMBER 1 OF EACH YEAR, THE COMMISSION SHALL  
31 MAKE A REPORT TO THE HOUSE OF REPRESENTATIVES TRANSPORTATION  
32 AND LOCAL GOVERNMENT COMMITTEE, THE HOUSE OF REPRESENTATIVES

1 BUSINESS AFFAIRS AND LABOR COMMITTEE, THE SENATE BUSINESS, LABOR,  
2 AND TECHNOLOGY COMMITTEE, AND THE SENATE TRANSPORTATION AND  
3 ENERGY COMMITTEE, OR ANY SUCCESSOR COMMITTEES. THE REPORT  
4 MUST:  
5 (A) ADDRESS THE FEES CHARGED FOR AND COMPLAINTS ARISING  
6 FROM NONCONSENSUAL TOWS;  
7 (B) CONTAIN THE RECOMMENDATIONS, INCLUDING RULE CHANGES,  
8 OF THE TASK FORCE, WHETHER THE RECOMMENDATIONS WERE  
9 IMPLEMENTED WITH OR WITHOUT MODIFICATION, AND AN ANALYSIS OF  
10 THE REASONS WHY THE COMMISSION MADE THESE DECISIONS.  
11 (II) THIS SUBSECTION (4)(d) IS REPEALED, EFFECTIVE JULY 1, 2026.  
12 (5) The task force has the following duties and powers:  
13 (a) To make comprehensive recommendations to the commission  
14 about the maximum rates that may be charged for the recovery, towing,  
15 and storage of a vehicle that has been towed without the owner's consent.  
16 The task force shall make ~~its first~~ comprehensive recommendations to the  
17 commission about the maximum rates ~~by~~ AFTER JULY 1, 2022, BUT NO  
18 LATER THAN September 1, ~~2015~~ 2022."
