SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

HB21-1014 be amended as follows:

1 Amend reengrossed bill, page 8, line 27, strike "WHEN" and substitute  
2 "UPON COMPLETION OF THE APPLICATION CREATED PURSUANT TO  
3 SUBSECTION (9.5)(b) OF THIS SECTION, WHEN".

4 Page 9, after line 11 insert:

5 "(b) (I) THE DEPARTMENT SHALL PROMULGATE A RULE CREATING  
6 AN APPLICATION AND RENEWAL FORM THAT IS SIGNED BY A PROFESSIONAL,  
7 UNDER PENALTY OF PERJURY, TO AFFIRM THAT THE DRIVER OR REGULAR  
8 PASSENGER OF A VEHICLE HAS A DISABILITY AND THE DISABILITY  
9 INTERFERES WITH THE PERSON'S ABILITY TO EFFECTIVELY COMMUNICATE  
10 WITH A PEACE OFFICER AND SETTING OUT THE PENALTIES FOR AFFIRMING  
11 BEFORE VERIFYING THAT THE PERSON HAS A DISABILITY THAT THE  
12 PERSON'S ABILITY TO EFFECTIVELY COMMUNICATE WITH A PEACE OFFICER.

13 (II) AS USED IN THIS SUBSECTION (9.5)(b), "PROFESSIONAL"  
14 MEANS A PHYSICIAN LICENSED TO PRACTICE MEDICINE UNDER ARTICLE 240  
15 OF TITLE 12 OR PRACTICING MEDICINE UNDER SECTION 12-240-107 (3)(i),  
16 A PHYSICIAN ASSISTANT LICENSED UNDER SECTION 12-240-113, A MENTAL  
17 HEALTH PROFESSIONAL LICENSED OR CERTIFIED UNDER ARTICLE 245 OF  
18 TITLE 12, AN ADVANCED PRACTICE NURSE REGISTERED UNDER SECTION  
19 12-255-111, A PERSON WITH A MASTER'S DEGREE IN REHABILITATION  
20 COUNSELING, OR A PHYSICIAN, PHYSICIAN ASSISTANT, MENTAL HEALTH  
21 PROFESSIONAL, OR ADVANCED PRACTICE NURSE AUTHORIZED TO PRACTICE  
22 PROFESSIONALLY BY ANOTHER STATE THAT SHARES A COMMON BORDER  
23 WITH COLORADO."

24 Reletter succeeding paragraphs accordingly.

25 Page 10, line 3, strike "(9)" and substitute "(9.5)".
