SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business, Labor, & Technology.

HB21-1239 be amended as follows:

1 Amend reengrossed bill, page 16, line 3, strike "OFFERS" and substitute
2 "OFFERS:".

3 Page 16, strike line 4 and substitute:

4 "(I) A ONE-STEP ONLINE CANCELLATION LINK THAT IS:".

5 Page 16, line 5, strike "(I)" and substitute "(A)".

6 Page 16, line 8, strike "(II)" and substitute "(B)".

7 Page 16, line 11, strike "ACCOUNT." and substitute "ACCOUNT; OR".

8 Page 16, after line 11 insert:

9 "(II) AN IN-PERSON MECHANISM FOR CANCELING AN AUTOMATIC
10 RENEWAL CONTRACT OR TRIAL PERIOD OFFER, WHICH MECHANISM:

11 (A) IS AT A PHYSICAL LOCATION WHERE THE CONSUMER
12 REGULARLY UTILIZES ANY GOODS OR SERVICES THAT ARE SUBJECT TO THE
13 AUTOMATIC RENEWAL CONTRACT; AND

14 (B) SATISFIES THE REQUIREMENTS OF THIS SUBSECTION (2)(d).".

15 Page 17, strike line 3 and substitute:

16 "(I) PHYSICAL MAIL;".

17 Page 17, strike lines 10 through 12 and substitute:

18 "(b) IN THE CASE OF A NOTICE DESCRIBED IN SUBSECTION (4)(a) OF
19 THIS SECTION, WHICH NOTICE IS PROVIDED BY PHYSICAL MAIL, THE NOTICE
20 SHALL BE PROVIDED NO MORE THAN FORTY-FIVE DAYS BEFORE THE FIRST
21 AUTOMATIC RENEWAL AND NO MORE THAN FORTY-FIVE DAYS BEFORE
22 EACH AUTOMATIC RENEWAL THEREAFTER.

23 (c) IN THE CASE OF A NOTICE DESCRIBED IN SUBSECTION (4)(a) OF
24 THIS SECTION, WHICH NOTICE IS PROVIDED BY E-MAIL OR ANOTHER EASILY
25 ACCESSIBLE FORM OF COMMUNICATION, THE NOTICE SHALL BE PROVIDED
26 NO MORE THAN".

27 Page 18, after line 16 insert:

28 "(6) THE ATTORNEY GENERAL AND THE DISTRICT ATTORNEYS OF
29 THE STATE HAVE EXCLUSIVE AUTHORITY TO ENFORCE THIS SECTION.".
