HB21-1315 be amended as follows:

5 ~~C.R.S.~~ MONEY TRANSFERRED FROM THE MARIJUANA TAX CASH FUND

- 7 Page 4, strike line 18 and substitute "**- legislative declaration - repeal.**

- 9 Page 4, line 21, strike "(a)" and substitute "(I)".
- 10 Page 4, line 23, strike "(b)" and substitute "(II)".

12 DISTRIBUTED IN ACCORDANCE WITH SUBSECTION (4.8)(b) OF THIS  
13 SECTION;".
- 14 Page 4, line 25, strike "(c)" and substitute "(III)".
- 15 Page 4, line 27, strike "24-4.2-103." and substitute "24-4.2-103,  
16 DISTRIBUTED IN ACCORDANCE WITH SUBSECTION (4.8)(c) OF THIS SECTION.  
17 (b) THE STATE COURT ADMINISTRATOR SHALL DISTRIBUTE THE  
18 MONEY TRANSFERRED PURSUANT TO SECTION (4.8)(a)(II) OF THIS SECTION  
19 TO THE CRIME VICTIM COMPENSATION FUND IN EACH JUDICIAL DISTRICT IN  
20 PROPORTION TO EACH DISTRICT'S PERCENTAGE OF TOTAL STATEWIDE  
21 SURCHARGES COLLECTED PURSUANT TO SECTION 24-4.1-117 (2) FOR THE  
22 THREE-YEAR FISCAL YEAR PERIOD BEGINNING JULY 1, 2016. THE STATE  
23 COURT ADMINISTRATOR SHALL NOT RETAIN ANY MONEY TRANSFERRED  
24 PURSUANT TO SUBSECTION (4.8)(a)(II) OF THIS SECTION FOR ITS  
25 ADMINISTRATIVE COSTS ASSOCIATED WITH MAKING THE DISTRIBUTION.  
26 (c) THE STATE COURT ADMINISTRATOR SHALL DISTRIBUTE THE  
27 MONEY TRANSFERRED PURSUANT TO SUBSECTION (4.8)(a)(III) OF THIS  
28 SECTION TO THE VICTIMS AND WITNESSES ASSISTANCE AND LAW  
29 ENFORCEMENT FUND IN EACH JUDICIAL DISTRICT IN PROPORTION TO EACH  
30 DISTRICT'S PERCENTAGE OF TOTAL STATEWIDE SURCHARGES COLLECTED  
31 PURSUANT TO SECTION 24-4.2-103 (1) FOR THE THREE-YEAR FISCAL YEAR  
32 PERIOD BEGINNING JULY 1, 2016. THE STATE COURT ADMINISTRATOR  
33 SHALL NOT RETAIN ANY MONEY TRANSFERRED PURSUANT TO SUBSECTION  
34 (4.8)(a)(III) OF THIS SECTION FOR ITS ADMINISTRATIVE COSTS ASSOCIATED  
35 WITH MAKING THE DISTRIBUTION."."
