HB21-1315 be amended as follows:

1 Amend the Judiciary Committee Report, dated May 19, 2021, page 2,
2 before line 2, insert:

3 ~~"Page 14 of the printed bill, lines 6 through 10, strike "If the court orders~~
4 ~~a suitability assessment, the assessor shall provide the services for a fee~~
5 ~~of no more than forty dollars based on a sliding scale; however, the fee~~
6 ~~may be reduced by the court based on a sliding scale consistent with~~
7 ~~guidelines used to determine eligibility for appointment of counsel."~~ and
8 substitute "If the court orders a suitability assessment, the assessor shall
9 provide the services for a fee of no more than forty dollars based on a

14 Page 14 of the bill, lines 19 through 22 strike ~~"If the juvenile participates~~
15 ~~in a restorative justice practices victim-offender conference, the facilitator~~
16 ~~shall provide these services for a fee of no more than one hundred~~
17 ~~twenty-five dollars based on a sliding scale; however, the fee may be~~
18 ~~waived by the court."~~ and substitute "If the juvenile participates in a
19 restorative justice practices victim-offender conference, the facilitator
20 shall provide these services for a fee of no more than one hundred
21 twenty-five dollars based on a sliding scale ~~however, the fee may be~~
22 ~~waived by the court.~~ CONSISTENT WITH GUIDELINES USED TO DETERMINE
23 ELIGIBILITY FOR APPOINTMENT OF COUNSEL. THE COURT SHALL NOT
24 INCLUDE PAYMENT OF THIS FEE AS PART OF PART OF ANY COURT ORDER."

25 Page 15 of the bill, lines 11 through 13, strike ~~"for a fee of no more than~~
26 ~~one hundred twenty-five dollars based on a sliding scale; however, the fee~~
27 ~~may be waived by the court~~ WITHOUT A FEE." and substitute "for a fee of
28 no more than one hundred twenty-five dollars based on a sliding scale
29 ~~however, the fee may be waived by the court~~ CONSISTENT WITH
30 GUIDELINES USED TO DETERMINE ELIGIBILITY FOR APPOINTMENT OF
31 COUNSEL. THE COURT SHALL NOT INCLUDE PAYMENT OF THIS FEE AS PART
32 OF PART OF ANY COURT ORDER."."
