HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB21-260 be amended as follows:

- 1 Amend reengrossed bill, page 29, line 20, after the period add "EACH  
2 SUCH RETAIL SALE IS A SINGLE RETAIL DELIVERY REGARDLESS OF THE  
3 NUMBER OF SHIPMENTS NECESSARY TO DELIVER THE ITEMS OF TANGIBLE  
4 PERSONAL PROPERTY PURCHASED."
- 5 Page 63, line 3, after the period add "EACH SUCH RETAIL SALE IS A SINGLE  
6 RETAIL DELIVERY REGARDLESS OF THE NUMBER OF SHIPMENTS NECESSARY  
7 TO DELIVER THE ITEMS OF TANGIBLE PERSONAL PROPERTY PURCHASED."
- 8 Page 85, line 17, strike "2022-23," and substitute "2022-23 OR ANY  
9 SUBSEQUENT STATE FISCAL YEAR,".
- 10 Page 92, line 8, strike "PLUG-IN HYBRID" and substitute "COMMERCIAL".
- 11 Page 93, line 18, after "ADJUSTED" insert "OR, DUE TO INCREASED USE OF  
12 SUCH MOTOR VEHICLES, FEES SHOULD ALSO BE IMPOSED ON HYDROGEN  
13 FUEL CELL MOTOR VEHICLES THAT ARE POWERED BY ELECTRICITY  
14 PRODUCED FROM A FUEL CELL THAT USES HYDROGEN GAS AS FUEL".
- 15 Page 94, line 23, strike "VEHICLE," and substitute "VEHICLE".
- 16 Page 114, line 4, strike "TWENTY-TWO" and substitute "TWENTY AND  
17 ONE-HALF".
- 18 Page 114, line 5, strike "TWENTY-TWO" and substitute "TWENTY AND  
19 ONE-HALF".
- 20 Page 120, line 17, after the period add "EACH SUCH RETAIL SALE IS A  
21 SINGLE RETAIL DELIVERY REGARDLESS OF THE NUMBER OF SHIPMENTS  
22 NECESSARY TO DELIVER THE ITEMS OF TANGIBLE PERSONAL PROPERTY  
23 PURCHASED."
- 24 Page 153, line 24, strike "project." and substitute "project OR TUNNEL  
25 PROJECT."
- 26 Page 158, line 24, strike "(5)(g.7), "INFLATION" MEANS" and substitute  
27 "(5)(g.7):  
28 (A) "INFLATION" MEANS".
- 29 Page 159, after line 5 insert:

1           "(B) "RETAIL DELIVERY" MEANS A RETAIL SALE OF TANGIBLE  
2 PERSONAL PROPERTY BY A RETAILER FOR DELIVERY BY A MOTOR VEHICLE  
3 OWNED OR OPERATED BY THE RETAILER OR ANY OTHER PERSON TO THE  
4 PURCHASER AT A LOCATION IN THE STATE, WHICH SALE INCLUDES AT  
5 LEAST ONE ITEM OF TANGIBLE PERSONAL PROPERTY THAT IS SUBJECT TO  
6 TAXATION UNDER ARTICLE 26 OF TITLE 39. EACH SUCH RETAIL SALE IS A  
7 SINGLE RETAIL DELIVERY REGARDLESS OF THE NUMBER OF SHIPMENTS  
8 NECESSARY TO DELIVER THE ITEMS OF TANGIBLE PERSONAL PROPERTY  
9 PURCHASED."

10 Page 173, line 15, after the period add "EACH SUCH RETAIL SALE IS A  
11 SINGLE RETAIL DELIVERY REGARDLESS OF THE NUMBER OF SHIPMENTS  
12 NECESSARY TO DELIVER THE ITEMS OF TANGIBLE PERSONAL PROPERTY  
13 PURCHASED."

14 Page 190, line 10, after the period add "EACH SUCH RETAIL SALE IS A  
15 SINGLE RETAIL DELIVERY REGARDLESS OF THE NUMBER OF SHIPMENTS  
16 NECESSARY TO DELIVER THE ITEMS OF TANGIBLE PERSONAL PROPERTY  
17 PURCHASED."
