HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.HB21-1315 be amended as follows:

1 Amend the Judiciary Committee Report, dated May 19, 2021, page 3,
2 after line 8, insert:

3 ~~"Page 23 of the printed bill, lines 24 through 27, strike "If the court orders~~
4 ~~a suitability assessment, the assessor shall provide the services for a fee~~
5 ~~of no more than forty dollars based on a sliding scale; however, the fee~~
6 ~~may be reduced by the court based on a sliding scale consistent with~~
7 ~~guidelines"~~ and substitute "If the court orders a suitability assessment, the
8 assessor shall provide the services for a fee of no more than forty dollars

11 eligibility for appointment of counsel. THE COURT SHALL NOT INCLUDE

15 Page 24 of the bill, lines 10 through 14 strike ~~"If the juvenile participates~~
16 ~~in a restorative justice practices victim-offender conference, the facilitator~~
17 ~~shall provide these services for a fee of no more than one hundred~~
18 ~~twenty-five dollars based on a sliding scale; however, the fee may be~~
19 ~~waived by the court."~~ and substitute "If the juvenile participates in a
20 restorative justice practices victim-offender conference, the facilitator
21 shall provide these services for a fee of no more than one hundred

26 Page 25 of the bill, lines 3 through 5, strike ~~"for a fee of no more than one~~
27 ~~hundred twenty-five dollars based on a sliding scale; however, the fee~~
28 ~~may be waived by the court~~ WITHOUT A FEE." and substitute "for a fee of
29 no more than one hundred twenty-five dollars based on a sliding scale
30 ~~however, the fee may be waived by the court~~ CONSISTENT WITH
31 GUIDELINES USED TO DETERMINE ELIGIBILITY FOR APPOINTMENT OF
32 COUNSEL. THE COURT SHALL NOT INCLUDE PAYMENT OF THIS FEE AS PART
33 OF PART OF ANY COURT ORDER."."
