Committee on Judiciary.

HB21-1315 be amended as follows:

1 Amend printed bill, page 28, after line 6, insert:

2 "SECTION 34. In Colorado Revised Statutes, 18-25-101, **amend**
3 (3)(a) as follows:

4 **18-25-101. Restorative justice surcharge - definitions.**

5 (3) (a) There is created in the state treasury the restorative justice
6 surcharge fund that consists of money received by the state treasurer
7 pursuant to this section and section 13-3-116 (4.5) AND ANY OTHER
8 MONEY THAT THE GENERAL ASSEMBLY MAY APPROPRIATE OR TRANSFER
9 TO THE FUND. The money in the fund is subject to annual appropriation by
10 the general assembly to the judicial department for distribution to judicial
11 districts that offer restorative justice programs and to the restorative
12 justice coordinating council for administrative expenses.

13 **SECTION 35.** In Colorado Revised Statutes, 24-4.1-117, **amend**
14 (2) as follows:

15 **24-4.1-117. Fund created - control of fund.** (2) The fund ~~shall~~
16 ~~consist~~ CONSISTS of all ~~moneys~~ MONEY paid as a cost or surcharge levied
17 on criminal actions, as provided in section 24-4.1-119; any federal
18 ~~moneys~~ MONEY available to state or local governments for victim
19 compensation; all ~~moneys~~ MONEY received from any action or suit to
20 recover damages from an assailant for a compensable crime which was
21 the basis for an award of, and limited to, compensation received under
22 this part 1; ~~and~~ any restitution paid by an assailant to a victim for damages
23 for a compensable crime which was the basis for an award received under
24 this part 1 and for damages for which the victim has received an award of,
25 and limited to, compensation received under this part 1; AND ANY OTHER
26 MONEY THAT THE GENERAL ASSEMBLY MAY APPROPRIATE OR TRANSFER
27 TO THE FUND.

28 **SECTION 36.** In Colorado Revised Statutes, 24-4.2-103, **amend**
29 (1.5) as follows:

30 **24-4.2-103. Victims and witnesses assistance and law**
31 **enforcement fund - control of fund.** (1.5) In addition to the ~~moneys~~
32 MONEY paid into the fund pursuant to subsection (1) of this section, the
33 fund ~~shall consist~~ CONSISTS of ~~moneys~~ MONEY paid pursuant to section
34 17-27-104 (4)(b)(IV) ~~C.R.S.~~ AND ANY OTHER MONEY THAT THE GENERAL
35 ASSEMBLY MAY APPROPRIATE OR TRANSFER TO THE FUND."
