HB21-1305 be amended as follows:

- 1 Amend reengrossed bill, page 3, line 25, after "(1)(g)," insert "(3)".
- 2 Page 3, line 26, strike "(3.5)(b)(II)" and substitute "(3.5)(b)(II); and **add**
- 3 (1.5)".
- 4 Page 4, line 9, strike "(1)(e)" and substitute (1)(e.5)".
- 5 Page 4, after line 13 insert:
- 6 "(1.5) THE BOARD MAY WAIVE ANY EDUCATION REQUIREMENTS IN
- 7 SUBSECTION (1)(e) OF THIS SECTION UNTIL THE DEPARTMENT OF HUMAN
- 8 SERVICES ESTABLISHES THE EDUCATION REQUIREMENTS FOR LICENSURE
- 9 PURSUANT TO SECTION 27-80-108 (1)(e.5). THIS SUBSECTION (1.5) IS
- 10 REPEALED, EFFECTIVE MARCH 1, 2022.
- 11 (3) The state board of addiction counselor examiners shall
- 12 promulgate rules for certification of addiction counselors; except that the
- 13 state board of human services in the department of human services shall
- 14 establish by rule education requirements for LICENSURE AND certification
- 15 in accordance with section 27-80-108 (1)(e) AND (1)(e.5)".
- 16 Page 5, after line 19 insert:
- 17 "**SECTION 5.** In Colorado Revised Statutes, 12-245-806, **amend**
- 18 (1)(b) introductory portion as follows:
- 19 **12-245-806. Continuing professional competency - rules -**
- 20 **definition.** (1) (b) ~~The office of behavioral health in the department of~~
- 21 ~~human services~~ BOARD, in consultation with ~~other~~ stakeholders, shall
- 22 adopt rules ON OR BEFORE MARCH 1, 2022, establishing a continuing
- 23 professional competency program that includes, at a minimum, the
- 24 following elements:".
- 25 Renumber succeeding sections accordingly.
- 26 Page 5, line 21, strike "(2)" and substitute "(2); and **add** (1)(e.5)".
- 27 Page 5, strike line 22 and substitute:
- 28 "**27-80-108. Rules.** (1) The state board of human services,
- 29 created in section 26-1-107, has the power to promulgate rules governing
- 30 the provisions of this article 80. The rules may include, but are not limited
- 31 to:
- 32 (e.5) ON OR BEFORE MARCH 1, 2022, STANDARDS THAT ADDICTION
- 33 COUNSELORS MUST MEET TO PARTICIPATE IN PUBLIC PROGRAMS OR TO

1 PROVIDE PURCHASED SERVICES AND EDUCATION REQUIREMENTS
2 NECESSARY TO BE LICENSED BY THE DIRECTOR OF THE DIVISION OF
3 PROFESSIONS AND OCCUPATIONS, PURSUANT TO PART 8 OF ARTICLE 245 OF
4 TITLE 12;
5 (2) In the rules promulgated pursuant to".
