11 HB20-1235 be amended as follows:

12 Amend printed bill, page 3, line 20, strike "definitions." and substitute "definitions - repeal."

13 Page 7, after line 2 insert:

14 "(b) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (3)(a) OF  
15 THIS SECTION, THE FAMILY-SCHOOL PARTNERSHIP COORDINATOR IS NOT  
16 REQUIRED TO INCLUDE IN THE COORDINATOR'S REPORT ANY INFORMATION  
17 THAT IS INCLUDED IN ANY OTHER REPORT PUBLISHED BY THE  
18 DEPARTMENT. FOR ANY INFORMATION OMITTED PURSUANT TO THIS  
19 SUBSECTION (3)(b), THE COORDINATOR SHALL INCLUDE IN THE  
20 COORDINATOR'S REPORT AN EXPLANATION THAT THE INFORMATION WAS  
21 OMITTED AND A REFERENCE TO THE REPORT THAT INCLUDES THE  
22 INFORMATION." ✓

23 Reletter succeeding paragraph accordingly. ✓

24 Page 7, strike line 5 and substitute "STUDENT ORGANIZATIONS AND TO THE  
25 PUBLIC ON ITS WEBSITE IN ENGLISH AND SPANISH. THE DEPARTMENT  
26 SHALL ALSO PUBLISH THE REPORT ON ITS WEBSITE IN ANY OTHER  
27 LANGUAGE AT THE REQUEST OF A LOCAL PARENT, FAMILY, AND STUDENT  
ORGANIZATION. NOTWITHSTANDING". ✓

28 Page 7, line 6, strike "NOTWITHSTANDING". ✓

29 Page 7, line 7, before "SUBMIT" insert "THE DEPARTMENT SHALL". ✓

30 Page 7, after line 8 insert:

31 "(d) IN ITS FINAL REPORT BEFORE THE HOUSE AND SENATE  
32 COMMITTEES OF REFERENCE PURSUANT TO SECTION 2-7-203 PRIOR TO THE  
33 REPEAL OF THIS SECTION, THE DEPARTMENT SHALL INCLUDE A  
34 RECOMMENDATION OF WHETHER THE FAMILY-SCHOOL PARTNERSHIP  
35 COORDINATOR POSITION SHOULD BE EXTENDED.

36 (4) THIS SECTION IS REPEALED, EFFECTIVE JUNE 30, 2025." ✓
