HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.HB20-1240 be amended as follows:

- 1 Amend printed bill, page 6, strike lines 6 and 7 and substitute
2 "NECESSARY TO DIRECT THE COMMISSIONER OF EDUCATION TO CONVENE
3 AN EARLY COLLEGE POLICY DEVELOPMENT TASK FORCE".
- 4 Page 6, strike lines 15 and 16.
- 5 Renumber succeeding subsections accordingly.
- 6 Page 6, after line 19 insert:
7 "(2) "COMMISSIONER" MEANS THE COMMISSIONER OF EDUCATION
8 APPOINTED BY THE STATE BOARD OF EDUCATION PURSUANT TO SECTION
9 1 OF ARTICLE IX OF THE STATE CONSTITUTION."
- 10 Renumber succeeding subsections accordingly.
- 11 Page 7, strike lines 8 through 27 and substitute:
12 "(7) "TASK FORCE" MEANS THE EARLY COLLEGE POLICY
13 DEVELOPMENT TASK FORCE CONVENED BY THE COMMISSIONER PURSUANT
14 TO SECTION 22-35.3-203.
15 **22-35.3-203. Early college policy development task force.**
16 (1) NO LATER THAN JULY 1, 2020, THE COMMISSIONER SHALL CONVENE
17 THE EARLY COLLEGE POLICY DEVELOPMENT TASK FORCE. THE TASK FORCE
18 MEMBERSHIP CONSISTS OF:
19 (a) THE COMMISSIONER OR THE COMMISSIONER'S DESIGNEE;
20 (b) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF HIGHER
21 EDUCATION OR THE EXECUTIVE DIRECTOR'S DESIGNEE; AND
22 (c) THE FOLLOWING INDIVIDUALS SELECTED BY THE
23 COMMISSIONER:
24 (I) INDIVIDUALS WHO ARE SERVING ON THE EDUCATION
25 LEADERSHIP COUNCIL;
26 (II) TWO TEACHERS EMPLOYED IN PUBLIC SCHOOLS IN COLORADO,
27 AT LEAST ONE OF WHOM HOLDS A LICENSE ISSUED PURSUANT TO SECTION
28 22-60.5-201, WHO BOTH HAVE EXPERIENCE IN CONCURRENT ENROLLMENT
29 PROGRAMMING; AND
30 (III) TWO SCHOOL DISTRICT ADMINISTRATORS WHO BOTH HAVE
31 EXPERIENCE IN CONCURRENT ENROLLMENT PROGRAMMING."
