HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB20-042 be amended as follows:

1 Amend the reengrossed bill, strike everything below the enacting clause  
2 and substitute:

3 "SECTION 1. In Colorado Revised Statutes, 18-1.9-103, add  
4 (2)(d) as follows:

5 **18-1.9-103. Legislative oversight committee concerning the**  
6 **treatment of persons with mental health disorders in the criminal and**  
7 **juvenile justice systems - creation - duties. (2) Duties.**  
8 (d) NOTWITHSTANDING THE REQUIREMENTS OF THIS SUBSECTION (2), THE  
9 COMMITTEE SHALL NOT MEET OR RECOMMEND LEGISLATION DURING THE  
10 2020 INTERIM, OR DURING ANY INTERIM IN WHICH THE GENERAL  
11 ASSEMBLY HAS SUSPENDED INTERIM COMMITTEE ACTIVITIES, AND IS NOT  
12 REQUIRED TO SUBMIT AN ANNUAL REPORT TO THE GENERAL ASSEMBLY ON  
13 OR BEFORE JANUARY 15, 2021, OR ANY JANUARY FOLLOWING THE  
14 SUSPENSION OF INTERIM COMMITTEE ACTIVITIES BY THE GENERAL  
15 ASSEMBLY.

16 SECTION 2. In Colorado Revised Statutes, 18-1.9-104, add (7)  
17 as follows:

18 **18-1.9-104. Task force concerning the treatment of persons**  
19 **with mental health disorders in the criminal and juvenile justice**  
20 **systems - creation - membership - duties. (7) NOTWITHSTANDING ANY**  
21 **PROVISION OF THIS SECTION, THE TASK FORCE IS NOT REQUIRED TO MEET,**  
22 **SUBMIT ANNUAL POLICY AND LEGISLATIVE RECOMMENDATIONS, OR**  
23 **SUBMIT AN ANNUAL REPORT TO THE COMMITTEE DURING THE 2020**  
24 **INTERIM OR DURING ANY INTERIM IN WHICH THE GENERAL ASSEMBLY HAS**  
25 **SUSPENDED INTERIM COMMITTEE ACTIVITIES.**

26 SECTION 3. In Colorado Revised Statutes, amend 18-1.9-107  
27 as follows:

28 **18-1.9-107. Repeal of article.** This ~~article~~ ARTICLE 1.9 is  
29 repealed, effective ~~July 1, 2020~~ JULY 1, 2023.

30 SECTION 4. **Safety clause.** The general assembly hereby finds,  
31 determines, and declares that this act is necessary for the immediate  
32 preservation of the public peace, health, or safety."

33 Page 1, lines 104 and 105, strike "SYSTEMS, AND, IN CONNECTION  
34 THEREWITH, MAKING AN APPROPRIATION." and substitute "SYSTEMS."
