SB19-059 be amended as follows:

- 17 PROVIDER".
- 18 Page 5, line 12, strike "**Eligible school districts**" and substitute
- 19 "**Eligibility**".
- 20 Page 5, strike line 13 and substitute: "**grant money - report.** (1) (a) A
- 21 LOCAL EDUCATION PROVIDER MAY APPLY FOR A GRANT PURSUANT TO THIS
- 22 SECTION; EXCEPT THAT, WHEN A SCHOOL DISTRICT SUBMITS AN
- 23 APPLICATION AND IS ELIGIBLE FOR A GRANT PURSUANT TO THIS PART 2, A
- 24 SCHOOL OPERATING WITHIN THAT DISTRICT MAY NOT SUBMIT AN
- 25 APPLICATION.
 - 26 (b) AN APPLICATION FROM AN INDIVIDUAL SCHOOL MUST BE
 - 27 SUBMITTED BY THE CHIEF ADMINISTRATIVE OFFICER OF THE SCHOOL AND,
 - 28 IF THE SCHOOL IS NOT A CHARTER SCHOOL, THE SCHOOL MUST NOTIFY THE
 - 29 SUPERINTENDENT OF THE SCHOOL DISTRICT OF THE APPLICATION.
- 30 (2) (a) A LOCAL EDUCATION PROVIDER IS ELIGIBLE FOR THE".

- 9 (II) ANY OTHER MEASURE, APPLIED TO ALL STUDENTS ENROLLED
- 10 IN A LOCAL EDUCATION PROVIDER, THAT, IN THE JUDGMENT OF THE LOCAL
- 11 EDUCATION PROVIDER, IS AN INDICATOR THAT A STUDENT DEMONSTRATES
- 12 THE ABILITY TO SUCCEED IN AN ADVANCED COURSE."
- 13 Page 6, line 19, strike "SCHOOL DISTRICT'S" and substitute "LOCAL
- 14 EDUCATION PROVIDER'S".
- 15 Page 6, line 23, strike "SCHOOL DISTRICT'S" and substitute "LOCAL
- 16 EDUCATION PROVIDER'S".
- 17 Page 6, line 27, strike "(3)" and substitute "(4)".
- 18 Page 7, lines 12 and 13, strike "IN THE SCHOOL DISTRICT" and substitute
- 19 "WITH THE LOCAL EDUCATION PROVIDER".
- 20 Page 7, line 15, strike "SCHOOL DISTRICTS THAT RECEIVE" and substitute
- 21 "A LOCAL EDUCATION PROVIDER THAT RECEIVES".
- 22 Strike "SCHOOL DISTRICT" and substitute "LOCAL EDUCATION PROVIDER"
- 23 on: **Page 4**, lines 14, 15, and 22; **Page 5**, lines 8 and 14; **Page 6**, lines 18
- 24 and 25; **Page 7**, lines 6 and 20.
- 25 Strike "AN ELIGIBLE SCHOOL DISTRICT" and substitute "A LOCAL
- 26 EDUCATION PROVIDER" on: **Page 6**, lines 5, 9, 12, and 14 and 15; **Page 7**,
- 27 line 2.
