SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB19-036 be amended as follows:

- 1 Amend printed bill, page 2, line 16, strike "CRIMINAL".
- 2 Page 2, lines 18 and 19, strike "COMMITTED TO THE CUSTODY OF A
3 COUNTY JAIL" and substitute "TAKEN INTO CUSTODY".
- 4 Page 4, line 22, after "DEFENDANT'S" insert "OR JUVENILE PARTICIPANT'S".
- 5 Page 5, strike line 12 and substitute:
6 "(h) AS USED IN THIS SUBSECTION (11), UNLESS THE CONTEXT
7 OTHERWISE REQUIRES:
8 (I) "ELIGIBLE COURT" MEANS".
- 9 Page 5, after line 15 insert:
10 "(II) "JUVENILE PARTICIPANT" MEANS A JUVENILE WHO HAS BEEN
11 ALLEGED TO HAVE COMMITTED A DELINQUENT ACT, AS DEFINED IN
12 SECTION 19-1-103 (36), WHO IS REQUIRED TO APPEAR BEFORE AN ELIGIBLE
13 COURT. "JUVENILE PARTICIPANT" INCLUDES THE JUVENILE'S PARENT,
14 GUARDIAN, OR LEGAL CUSTODIAN."
- 15 Page 5, after line 26 insert:
16 "SECTION 3. In Colorado Revised Statutes, 19-2-507, add
17 (5)(b.5) as follows:
18 **19-2-507. Duty of officer - screening teams - notification -
19 release or detention.** (5) (b.5) A LAW ENFORCEMENT OFFICER WHO
20 SERVES A JUVENILE OR A JUVENILE'S PARENT, GUARDIAN, OR LEGAL
21 CUSTODIAN WITH A WRITTEN PROMISE TO APPEAR IN A COURT THAT
22 PARTICIPATES IN THE COURT REMINDER PROGRAM ESTABLISHED IN
23 SECTION 13-3-101 (11)(a)(I) SHALL NOTIFY THE PERSON SERVED THAT THE
24 JUVENILE AND THE JUVENILE'S PARENT, GUARDIAN, OR LEGAL CUSTODIAN
25 CAN ELECT TO PROVIDE A MOBILE TELEPHONE NUMBER THAT WILL BE USED
26 BY THE COURT SOLELY TO PROVIDE TEXT MESSAGE REMINDERS FOR
27 FUTURE COURT DATES AND SHALL PROVIDE THE OPPORTUNITY FOR THE
28 JUVENILE AND THE JUVENILE'S PARENT, GUARDIAN, OR LEGAL CUSTODIAN
29 TO PROVIDE A MOBILE TELEPHONE NUMBER OR UPDATE A MOBILE
30 TELEPHONE NUMBER FOR THAT PURPOSE.
- 31 **SECTION 4.** In Colorado Revised Statutes, 19-2-509, add (9) as
32 follows:
33 **19-2-509. Bail.** (9) A JUVENILE RELEASED PURSUANT TO THIS
34 SECTION AND ORDERED TO APPEAR IN A COURT THAT PARTICIPATES IN THE
35 COURT REMINDER PROGRAM ESTABLISHED IN SECTION 13-3-101 (11)(a)(I),

1 AND THE JUVENILE'S PARENT, GUARDIAN, OR LEGAL CUSTODIAN, MUST BE
2 NOTIFIED THAT THE JUVENILE AND THE JUVENILE'S PARENT, GUARDIAN, OR
3 LEGAL CUSTODIAN CAN ELECT TO PROVIDE A MOBILE TELEPHONE NUMBER
4 THAT WILL BE USED BY THE COURT SOLELY TO PROVIDE TEXT MESSAGE
5 REMINDERS FOR FUTURE COURT DATES AND MUST BE PROVIDED THE
6 OPPORTUNITY TO PROVIDE A MOBILE TELEPHONE NUMBER OR UPDATE A
7 MOBILE TELEPHONE NUMBER FOR THAT PURPOSE.

8 **SECTION 5.** In Colorado Revised Statutes, 19-2-514, add (11)
9 as follows:

10 **19-2-514. Summons - issuance - contents - service.** (11) A
11 PERSON THAT SERVES A JUVENILE OR A JUVENILE'S PARENT, GUARDIAN, OR
12 LEGAL CUSTODIAN WITH A SUMMONS TO APPEAR IN A COURT THAT
13 PARTICIPATES IN THE COURT REMINDER PROGRAM ESTABLISHED IN
14 SECTION 13-3-101 (11)(a)(I) SHALL NOTIFY THE PERSON SERVED THAT THE
15 JUVENILE AND THE JUVENILE'S PARENT, GUARDIAN, OR LEGAL CUSTODIAN
16 CAN ELECT TO PROVIDE A MOBILE TELEPHONE NUMBER THAT WILL BE USED
17 BY THE COURT SOLELY TO PROVIDE TEXT MESSAGE REMINDERS FOR
18 FUTURE COURT DATES AND SHALL PROVIDE THE OPPORTUNITY FOR THE
19 JUVENILE AND THE JUVENILE'S PARENT, GUARDIAN, OR LEGAL CUSTODIAN
20 TO PROVIDE A MOBILE TELEPHONE NUMBER OR UPDATE A MOBILE
21 TELEPHONE NUMBER FOR THAT PURPOSE."

22 Renumber succeeding section accordingly.

23 After "DEFENDANTS" insert "AND JUVENILE PARTICIPANTS" on: **Page 2,**
24 lines 16 and 18; **Page 3,** lines 8, 10, 14, and 17; **Page 4,** lines 1, 5, 12, 15,
25 24, and 26; **Page 5,** lines 6 and 8.

26 After "DEFENDANT" insert "OR JUVENILE PARTICIPANT" on: **Page 3,** lines
27 11 and 25; **Page 5,** line 11.
