SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB19-050 be amended as follows:

- 1 Amend printed bill, page 2, line 7, strike "SUBSECTIONS (2) AND (3)" and  
2 substitute "SUBSECTION (2)".
- 3 Page 3, line 5, strike "JULY 1, 2020," and substitute "JANUARY 1, 2021,".
- 4 Page 3, lines 7 through 9, strike "AN ANNUAL AMOUNT NOT LESS THAN  
5 THE SALARY EARNED BY A FULL-TIME COUNTY COURT JUDGE WITHIN THE  
6 STATE OF COLORADO." and substitute "THE SUM NOT LESS THAN ONE  
7 HUNDRED FORTY THOUSAND DOLLARS PER ANNUM.".
- 8 Page 3, strike lines 13 through 21.
- 9 Page 4, line 3, strike "JULY 1, 2020." and substitute "JANUARY 1, 2021,".
- 10 Page 4, line 4, strike "repeal" and substitute "amend".
- 11 Page 4, lines 10 through 13, strike "AN ANNUAL AMOUNT NOT LESS THAN  
12 THE SALARY EARNED BY A FULL-TIME DISTRICT COURT JUDGE WITHIN THE  
13 STATE OF COLORADO AT THE TIME THE FOUR-YEAR DISTRICT ATTORNEY  
14 TERM BEGINS." and substitute "THE SUM NOT LESS THAN ONE HUNDRED  
15 SIXTY THOUSAND DOLLARS PER ANNUM.".
- 16 Page 4, line 19, after "attorneys:" add "PRIOR TO THE LEGISLATIVE  
17 SESSION COMMENCING IN JANUARY 2024, AND EVERY FOURTH  
18 LEGISLATIVE SESSION THEREAFTER, THE JOINT BUDGET COMMITTEE OF THE  
19 GENERAL ASSEMBLY, OR ANY SUCCESSOR COMMITTEE, SHALL REVIEW THE  
20 COMPENSATION OF ELECTED DISTRICT ATTORNEYS AND ASSISTANT  
21 DISTRICT ATTORNEYS AND INTRODUCE LEGISLATION, IF APPROPRIATE,  
22 CONSISTENT WITH THEIR RECOMMENDATIONS REGARDING INCREASES IN  
23 COMPENSATION FOR THE ELECTED DISTRICT ATTORNEYS AND ASSISTANT  
24 DISTRICT ATTORNEYS.".
- 25 Page 5, line 3, strike "JULY 1, 2020," and substitute "JANUARY 1, 2021,".
- 26 Page 5, strike lines 11 through 18.
