SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

SB19-065 be amended as follows:

- 1 Amend printed bill, page 2, line 7, after "PAY" insert "TO THE
- 2 DEPARTMENT, AT THE TIME OF APPLICATION,".
  
- 3 Page 3, after line 5 insert:
  
- 4 "(3) THE DEPARTMENT SHALL DEPOSIT THE FEES COLLECTED
- 5 PURSUANT TO THIS SECTION IN THE EMERGENCY MEDICAL SERVICES PEER
- 6 ASSISTANCE FUND, REFERRED TO IN THIS SECTION AS THE "FUND", WHICH
- 7 IS HEREBY CREATED IN THE STATE TREASURY. MONEY IN THE FUND IS NOT
- 8 SUBJECT TO ANNUAL APPROPRIATION BY THE GENERAL ASSEMBLY. THE
- 9 STATE TREASURER SHALL CREDIT ALL INTEREST AND INCOME DERIVED
- 10 FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE FUND TO THE
- 11 FUND.".
  
- 12 Renumber succeeding subsections accordingly.
  
- 13 Page 4, strike lines 12 through 16.
  
- 14 Reletter succeeding paragraphs accordingly.
  
- 15 Page 4, line 17, strike "COLLECTED," and substitute "COLLECTED FROM
- 16 THE DEPARTMENT,".
  
- 17 Page 5, strike lines 1 through 10.
  
- 18 Renumber succeeding subsections accordingly.
  
- 19 Page 6, strike lines 1 and 2 and substitute "THE PROGRAM. IF A
- 20 CERTIFICATE HOLDER OBJECTS TO THE SUSPENSION, THE CERTIFICATE
- 21 HOLDER MAY SUBMIT A WRITTEN REQUEST TO THE DEPARTMENT FOR THE
- 22 FORMAL HEARING ON THE SUSPENSION WITHIN TWO DAYS AFTER
- 23 RECEIVING NOTICE OF THE SUSPENSION AND THE DEPARTMENT SHALL
- 24 GRANT THE REQUEST. IN THE HEARING, THE CERTIFICATE HOLDER SHALL
- 25 HAVE THE BURDEN OF PROVING THAT THE CERTIFICATE HOLDER'S
- 26 CERTIFICATION SHOULD NOT BE SUSPENDED. THE HEARING".
  
- 27 Strike "BOARD" and substitute "DEPARTMENT" on: **Page 3**, lines 1, 6, 8,
- 28 14, and 26; **Page 4**, lines 2, 18, 19, and 23; **Page 5**, lines 11, 23, 25, and
- 29 27; and **Page 6**, lines 5 (twice), 7, and 19.
