## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.SB19-043 be amended as follows:

1 Amend reengrossed bill, page 3, after line 27 insert:

2 "SECTION 11. In Colorado Revised Statutes, 13-3-101, add (11)  
3 as follows:

4 **13-3-101. State court administrator - report - repeal.**  
5 (11) (a) ON OR BEFORE OCTOBER 1, 2019, AND ON OR BEFORE EACH  
6 OCTOBER 1 THEREAFTER, THE STATE COURT ADMINISTRATOR SHALL  
7 SUBMIT A REPORT TO THE JOINT BUDGET COMMITTEE OF THE GENERAL  
8 ASSEMBLY AND THE JUDICIARY COMMITTEES OF THE HOUSE OF  
9 REPRESENTATIVES AND THE SENATE, OR ANY SUCCESSOR COMMITTEES, ON  
10 CASE MANAGEMENT STATISTICS FOR THE PRIOR STATE FISCAL YEAR THAT  
11 INCLUDES:

12 (I) THE TOTAL NUMBER AND TYPES OF:  
13 (A) NEW DISTRICT COURT CASES ASSIGNED;  
14 (B) DISTRICT COURT CASES RESOLVED; AND  
15 (C) DISTRICT COURT CASES REMAINING ON THE DOCKET; AND  
16 (II) FOR EACH JUDICIAL DISTRICT AND EACH DISTRICT COURT  
17 JUDGE THE TOTAL NUMBER AND TYPES OF:  
18 (A) NEW DISTRICT COURT CASES ASSIGNED;  
19 (B) DISTRICT COURT CASES RESOLVED; AND  
20 (C) DISTRICT COURT CASES REMAINING ON THE DOCKET.

21 (b) NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), THE  
22 REQUIREMENT TO SUBMIT THE REPORT REQUIRED IN THIS SUBSECTION  
23 (11)(a) CONTINUES INDEFINITELY.

24 (c) BASED UPON THE REPORT GENERATED BY SUBSECTION (11)(a)  
25 OF THIS SECTION, THE GENERAL ASSEMBLY MAY REDUCE THE  
26 APPROPRIATIONS FOR THE JUDICIAL DEPARTMENT TO REDUCE THE NUMBER  
27 OF DISTRICT COURT JUDGES IN A JUDICIAL DISTRICT FROM THE NUMBER OF  
28 JUDGES AUTHORIZED PURSUANT TO SECTIONS 13-5-102 TO 13-5-123 UPON  
29 THE RETIREMENT, RESIGNATION, OR REMOVAL OF A JUDGE FROM THAT  
30 JUDICIAL DISTRICT."

31 Renumber succeeding sections accordingly.
