HB25-1112 be amended as follows:

1 Amend printed bill, page 5, before line 27 insert:

2 "SECTION 5. In Colorado Revised Statutes, **add** 42-4-1720 as  
3 follows:

4 **42-4-1720. Registration violations - dismissal upon compliance**  
5 **- notice required.** (1) A COURT MAY DISMISS A VIOLATION FOR FAILING  
6 TO REGISTER A VEHICLE, TRAILER, SEMITRAILER, OR MOTOR VEHICLE IN  
7 VIOLATION OF SECTION 42-3-103 (1) OR (4), 42-3-114, 42-3-115, OR  
8 42-6-140 OR OF THE RULES OF THE DEPARTMENT IMPLEMENTING SECTION  
9 42-3-102 IF:

10 (a) THE VEHICLE, TRAILER, SEMITRAILER, OR MOTOR VEHICLE WAS  
11 UNREGISTERED FOR NO MORE THAN FOUR MONTHS AT THE TIME OF THE  
12 VIOLATION;

13 (b) THE OWNER REGISTERED THE VEHICLE, TRAILER, SEMITRAILER,  
14 OR MOTOR VEHICLE BEFORE THE OWNER'S FIRST COURT DATE AS LISTED ON  
15 THE CITATION OR SUMMONS; AND

16 (c) THE OWNER PAYS TO THE COURT A THIRTY-DOLLAR  
17 ADMINISTRATIVE DISMISSAL FEE.

18 (2) A CITATION OR SUMMONS FORMS USED BY LAW ENFORCEMENT  
19 TO CHARGE A PERSON FOR A VIOLATION DESCRIBED IN THE INTRODUCTORY  
20 PORTION OF SUBSECTION (1) OF THIS SECTION MUST INCLUDE THE  
21 FOLLOWING NOTICE ON THE COPY GIVEN TO THE DEFENDANT'S COPY:

22 IF THIS CITATION OR SUMMONS CONTAINS AN OFFENSE FOR  
23 VIOLATING REGISTRATION REQUIREMENTS FOR A TRAILER,  
24 SEMITRAILER, OR MOTOR VEHICLE, YOU MAY BE ELIGIBLE TO  
25 HAVE THE REGISTRATION CHARGE **DISMISSED** BY THE  
26 COURT IF THE REGISTRATION THAT LED TO THIS CITATION  
27 OR SUMMONS IS EXPIRED FOR FOUR (4) MONTHS OR LESS AT  
28 THE TIME OF THE VIOLATION AND IF YOU OBTAIN OR RENEW  
29 THE TRAILER, SEMITRAILER, OR MOTOR VEHICLE  
30 REGISTRATION PRIOR TO THE FIRST COURT DATE LISTED ON  
31 THIS CITATION/SUMMONS. IF THIS OFFENSE IS DISMISSED BY  
32 THE COURT, THE COURT WILL REQUIRE A \$30  
33 ADMINISTRATIVE DISMISSAL FEE TO BE PAID TO THE  
34 COURT."
