HB19-1230 Quick Facts

What does it do?

- Creates statewide licenses to clarify lawful marijuana hospitality
- Allows local governments to create a framework for marijuana hospitality
- OPT-IN. A marijuana hospitality business cannot lawfully operate UNTIL a local government has passed an ordinance and licensing

What is a Hospitality Space?

- The designated area on the premises where marijuana hospitality is restricted to
- This is the area in the premises subject to Department regulation
- Consumption of tobacco products is prohibited in the hospitality space

Why a Hospitality Space?

- Allows facilities that may retain other licenses to offer this service including hotels and restaurants
- Allows existing viable businesses to add this license if their community permits it
- Ensures baseline consistency so consumers, tourists and law enforcement know what to expect

Business Viability and Equity

As a result of a multi-year stakeholder process, including vetoed legislation last session, this bill brings together diverse industry and advocacy stakeholders in support of a bill that:

- Address a consumer and tourism necessity
- Creates opportunity for existing AND new entrepreneurs
- Creates a *viable* business model for communities that have been thus far disenfranchised from this new industry.
