HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Insurance.HB19-1174 be amended as follows:

1 Amend printed bill, page 6, line 10, strike "FACILITY," and substitute
2 "FACILITY OTHER THAN ANY OUT-OF-NETWORK FACILITY OPERATED BY
3 THE DENVER HEALTH AND HOSPITAL AUTHORITY PURSUANT TO ARTICLE
4 29 OF TITLE 25,".

5 Page 6, after line 23 insert:

6 "(II) IF A COVERED PERSON RECEIVES EMERGENCY SERVICES AT
7 ANY OUT-OF-NETWORK FACILITY OPERATED BY THE DENVER HEALTH AND
8 HOSPITAL AUTHORITY CREATED IN SECTION 25-29-103, THE CARRIER
9 SHALL REIMBURSE THE OUT-OF-NETWORK FACILITY DIRECTLY IN
10 ACCORDANCE WITH SECTION 10-16-106.5 THE GREATER OF:

11 (A) THE CARRIER'S MEDIAN IN-NETWORK RATE OF
12 REIMBURSEMENT FOR THAT SERVICE PROVIDED IN A SIMILAR FACILITY OR
13 SETTING IN THE SAME GEOGRAPHIC AREA;

14 (B) TWO HUNDRED PERCENT OF THE MEDICARE REIMBURSEMENT
15 RATE FOR THE SAME SERVICE PROVIDED IN A SIMILAR FACILITY OR SETTING
16 IN THE SAME GEOGRAPHIC AREA; OR

17 (C) ONE HUNDRED PERCENT OF THE MEDIAN IN-NETWORK RATE OF
18 REIMBURSEMENT FOR THE SAME SERVICE PROVIDED IN A SIMILAR FACILITY
19 OR SETTING IN THE SAME GEOGRAPHIC AREA FOR THE PRIOR YEAR AS
20 DETERMINED BASED ON CLAIMS DATA FROM THE COLORADO ALL-PAYER
21 HEALTH CLAIMS DATABASE CREATED IN SECTION 25.5-1-204.".

22 Renumber succeeding subparagraph accordingly.

23 Page 17, line 21, strike "FACILITY" and substitute "FACILITY, OTHER THAN
24 ANY OUT-OF-NETWORK FACILITY OPERATED BY THE DENVER HEALTH AND
25 HOSPITAL AUTHORITY PURSUANT TO ARTICLE 29 OF TITLE 25,".

26 Page 18, after line 9 insert:

27 "(b) AN OUT-OF-NETWORK FACILITY OPERATED BY THE DENVER
28 HEALTH AND HOSPITAL AUTHORITY CREATED IN SECTION 25-29-103 MUST
29 SEND A CLAIM FOR EMERGENCY SERVICES TO THE CARRIER WITHIN ONE
30 HUNDRED EIGHTY DAYS AFTER THE DELIVERY OF SERVICES IN ORDER TO
31 RECEIVE REIMBURSEMENT AS SPECIFIED IN THIS SUBSECTION (3)(b). THE
32 REIMBURSEMENT RATE IS THE GREATER OF:

33 (I) THE CARRIER'S MEDIAN IN-NETWORK RATE OF REIMBURSEMENT
34 FOR THAT SERVICE PROVIDED IN A SIMILAR FACILITY OR SETTING IN THE
35 SAME GEOGRAPHIC AREA;

1 (II) TWO HUNDRED PERCENT OF THE MEDICARE REIMBURSEMENT
2 RATE FOR THE SAME SERVICE PROVIDED IN A SIMILAR FACILITY OR SETTING
3 IN THE SAME GEOGRAPHIC AREA; OR

4 (III) ONE HUNDRED PERCENT OF THE MEDIAN IN-NETWORK RATE
5 OF REIMBURSEMENT FOR THE SAME SERVICE PROVIDED IN A SIMILAR
6 FACILITY OR SETTING IN THE SAME GEOGRAPHIC AREA FOR THE PRIOR
7 YEAR AS DETERMINED BASED ON CLAIMS DATA FROM THE COLORADO
8 ALL-PAYER HEALTH CLAIMS DATABASE CREATED IN SECTION 25.5-1-204."

9 Reletter succeeding paragraphs accordingly.
