

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs & Labor.

HB25-1077 be amended as follows:

1 Amend printed bill, page 2, line 5, strike "the business of installing," and
2 substitute "~~the business of installing~~".

3 Page 2, after line 10 insert:

4 "SECTION 2. In Colorado Revised Statutes, **add** 12-155-126 as
5 follows:

6 **12-155-126. Backflow prevention devices - requirements -**
7 **service information provided to customer.** (1) ON AND AFTER JULY 1,
8 2025, A LICENSED PLUMBER WHO INSTALLS, TESTS, INSPECTS, REPAIRS, OR
9 REINSTALLS A BACKFLOW PREVENTION DEVICE SHALL AFFIX A TAG ON THE
10 BACKFLOW PREVENTION DEVICE THAT CONTAINS THE FOLLOWING
11 INFORMATION:

12 (a) THE NAME AND CONTACT INFORMATION OF THE BUSINESS WITH
13 WHICH THE LICENSED PLUMBER IS AFFILIATED;

14 (b) THE PLUMBING CONTRACTOR'S REGISTRATION NUMBER, OR THE
15 LICENSE NUMBER OF THE MASTER PLUMBER ATTACHED TO THE
16 CONTRACTOR, ISSUED BY THE BOARD;

17 (c) THE DATE THE SERVICE WAS PROVIDED; AND

18 (d) A DESCRIPTION OF THE SERVICE PROVIDED.

19 (2) A LICENSED PLUMBER MAY DOCUMENT MULTIPLE SERVICES ON
20 ONE TAG.

21 **SECTION 3.** In Colorado Revised Statutes, **add** 25-8-107 as
22 follows:

23 **25-8-107. Cross-connection control services - backflow**
24 **prevention devices - requirements - definitions.** (1) NOTHING IN THIS
25 SECTION APPLIES TO OR AFFECTS ANY OTHER SECTION IN THIS ARTICLE 8.

26 (2) NOTHING IN THIS SECTION REQUIRES THE DEPARTMENT OF
27 PUBLIC HEALTH AND ENVIRONMENT TO PERFORM INSPECTIONS.

28 (3) NOTHING IN THIS SECTION REQUIRES THE COMMISSION OR THE
29 DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT TO ENFORCE THIS
30 SECTION.

31 (4) (a) ON AND AFTER JULY 1, 2025, A CERTIFIED
32 CROSS-CONNECTION CONTROL TECHNICIAN OR A LICENSED PLUMBER WITH
33 A CROSS-CONNECTION CONTROL TECHNICIAN CERTIFICATION WHO TESTS
34 OR REPAIRS A BACKFLOW PREVENTION DEVICE SHALL AFFIX A TAG ON THE
35 BACKFLOW PREVENTION DEVICE THAT CONTAINS THE FOLLOWING
36 INFORMATION:

37 (I) THE NAME AND CONTACT INFORMATION OF THE BUSINESS WITH
38 WHICH THE CERTIFIED CROSS-CONNECTION CONTROL TECHNICIAN OR THE

1 LICENSED PLUMBER WITH A CROSS-CONNECTION CONTROL TECHNICIAN
2 CERTIFICATION IS AFFILIATED;
3 (II) THE DATE THE SERVICE WAS PROVIDED;
4 (III) A DESCRIPTION OF THE SERVICE PROVIDED; AND
5 (IV) THE ASSE OR ABPA CERTIFICATION NUMBER OF THE
6 CERTIFIED CROSS-CONNECTION CONTROL TECHNICIAN OR THE LICENSED
7 PLUMBER WITH A CROSS-CONNECTION CONTROL TECHNICIAN
8 CERTIFICATION, ALONG WITH THE PLUMBING CONTRACTOR'S
9 REGISTRATION NUMBER OR THE LICENSE NUMBER OF THE MASTER
10 PLUMBER ATTACHED TO THE CONTRACTOR, ISSUED BY THE STATE
11 PLUMBING BOARD, IF APPLICABLE.
12 (b) A CERTIFIED CROSS-CONNECTION CONTROL TECHNICIAN OR A
13 LICENSED PLUMBER WITH A CROSS-CONNECTION CONTROL TECHNICIAN
14 CERTIFICATION MAY DOCUMENT MULTIPLE SERVICES ON ONE TAG.
15 (5) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
16 REQUIRES:
17 (a) "ABPA" MEANS THE AMERICAN BACKFLOW PREVENTION
18 ASSOCIATION OR ITS SUCCESSOR ORGANIZATION.
19 (b) "ASSE" MEANS THE AMERICAN SOCIETY OF SANITARY
20 ENGINEERING OR ITS SUCCESSOR ORGANIZATION.
21 (c) "CERTIFIED CROSS-CONNECTION CONTROL TECHNICIAN" MEANS
22 AN INDIVIDUAL WHO POSSESSES A VALID BACKFLOW PREVENTION
23 ASSEMBLY TESTER CERTIFICATION FROM THE ASSE OR THE ABPA.
24 (d) "LICENSED PLUMBER WITH A CROSS-CONNECTION CONTROL
25 TECHNICIAN CERTIFICATION" MEANS AN INDIVIDUAL WHO IS A LICENSED
26 PLUMBER AND POSSESSES A VALID BACKFLOW PREVENTION ASSEMBLY
27 TESTER CERTIFICATION FROM THE ASSE OR THE ABPA."
