HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Local Government.

SB19-090 be amended as follows:

1 Amend reengrossed bill, page 5, strike line 1 and substitute:

2 **"6-1-1203. Insurance coverage during car sharing period.**

3 (1) (a) EXCEPT AS PROVIDED IN SUBSECTION (1)(b) OF THIS SECTION, A
4 CAR SHARING PROGRAM SHALL ASSUME THE LIABILITY OF A SHARED CAR
5 OWNER FOR ANY BODILY INJURY OR PROPERTY DAMAGE TO THIRD PARTIES,
6 OR UNINSURED AND UNDERINSURED MOTORIST OR PERSONAL INJURY
7 PROTECTION LOSSES, CAUSED BY THE SHARED CAR DRIVER DURING THE
8 SHARING PERIOD UP TO AN AMOUNT STATED IN THE CAR SHARING
9 AGREEMENT, BUT NOT LESS THAN THE MINIMUM AMOUNT OF FINANCIAL
10 RESPONSIBILITY REQUIRED BY ARTICLE 7 OF TITLE 42.

11 (b) A CAR SHARING PROGRAM DOES NOT ASSUME LIABILITY UNDER
12 THIS SUBSECTION (1) FOR ANY BODILY INJURY OR PROPERTY DAMAGE
13 CAUSED BY THE SHARED CAR OWNER MAKING AN INTENTIONAL OR
14 FRAUDULENT MATERIAL MISREPRESENTATION TO THE CAR SHARING
15 PROGRAM BEFORE OR DURING THE SHARING PERIOD IN WHICH THE LOSS
16 OCCURRED.

17 (2) A".

18 Renumber succeeding subsections accordingly.

19 Page 5, strike lines 14 through 18 and substitute:

20 "(3) THE FINANCIAL RESPONSIBILITY REQUIRED IN SUBSECTION (2)
21 OF THIS SECTION MAY BE SATISFIED BY AUTOMOBILE LIABILITY INSURANCE
22 THAT IS MAINTAINED BY ANY ONE OR A COMBINATION OF THE
23 FOLLOWING:".

24 Page 5, strike lines 22 and 23 and substitute:

25 "(4) THE INSURANCE DESCRIBED IN SUBSECTION (3) OF THIS
26 SECTION THAT SATISFIES THE INSURANCE REQUIREMENT IN SUBSECTION
27 (2)".

28 Page 5, strike line 25 and substitute:

29 "(5) (a) IF THE INSURANCE THAT COMPLIES WITH SUBSECTION (2)
30 OF".

31 Page 6, line 5, strike "(4)" and substitute "(5)".

- 1 Page 7, strike lines 11 through 26 and substitute "**liability insurance**
- 2 **policy - indemnification.** (1) AN AUTHORIZED INSURER MAY EXCLUDE
- 3 COVERAGE AND THE".

- 4 Renumber succeeding subsection accordingly.
