SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB19-224 be amended as follows:

1 Amend printed bill, page 28, after line 2, insert:

2 "(I) THE STATE LICENSING AUTHORITY SHALL PROMULGATE RULES  
3 THAT PREVENT OBSOLETE TESTING OF MEDICAL MARIJUANA AND MEDICAL  
4 MARIJUANA-INFUSED PRODUCTS, INCLUDING, BUT NOT LIMITED TO,  
5 POTENCY TESTING OF MEDICAL MARIJUANA ALLOCATED TO EXTRACTIONS,  
6 AND CONTAMINANT TESTING OF MEDICAL MARIJUANA-INFUSED PRODUCT  
7 WHEN ALL INPUTS OF THE MEDICAL MARIJUANA-INFUSED PRODUCT HAVE  
8 PASSED CONTAMINANT TESTING PURSUANT TO SUBSECTION (2)(a)(I) OF  
9 THIS SECTION."

10 Page 39, after line 27, insert:

11 "(IX) THE STATE LICENSING AUTHORITY SHALL PROMULGATE  
12 RULES THAT PREVENT OBSOLETE TESTING OF RETAIL MARIJUANA AND  
13 RETAIL MARIJUANA PRODUCTS, INCLUDING, BUT NOT LIMITED TO, POTENCY  
14 TESTING OF RETAIL MARIJUANA ALLOCATED TO EXTRACTIONS, AND  
15 CONTAMINANT TESTING OF RETAIL MARIJUANA PRODUCT WHEN ALL  
16 INPUTS OF THE RETAIL MARIJUANA PRODUCT HAVE PASSED CONTAMINANT  
17 TESTING PURSUANT TO THIS SUBSECTION (1)(d)."

18 Page 130, after line 10, insert:

19 "(IX) THE STATE LICENSING AUTHORITY SHALL PROMULGATE  
20 RULES THAT PREVENT OBSOLETE TESTING OF MARIJUANA AND MARIJUANA  
21 PRODUCTS, INCLUDING, BUT NOT LIMITED TO, POTENCY TESTING OF  
22 MARIJUANA ALLOCATED TO EXTRACTIONS, AND CONTAMINANT TESTING  
23 OF MARIJUANA PRODUCTS WHEN ALL INPUTS OF THE MARIJUANA PRODUCT  
24 HAVE PASSED CONTAMINANT TESTING PURSUANT TO SUBSECTION (2)(d)  
25 OF THIS SECTION."
