SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB19-222 be amended as follows:

- 1 Amend printed bill, page 9, line 23, strike "AND ADVOCATES." and  
2 substitute "BEHAVIORAL HEALTH PROVIDERS, BEHAVIORAL HEALTH  
3 ADMINISTRATIVE ORGANIZATIONS, AND ADVOCATES. MEMBERS OF THE  
4 ADVISORY BODY SHALL DISCLOSE POTENTIAL CONFLICTS OF INTEREST AND  
5 SHALL RECUSE THEMSELVES FROM VOTING WHEN THE MEMBER HAS A  
6 FINANCIAL INTEREST RELATED TO THE PROVISION OF DELIVERING CLINICAL  
7 SERVICES IN THE BEHAVIORAL HEALTH SAFETY NET SYSTEM."
  
- 8 Page 10, line 4, strike "DEVELOP A" and substitute "STRENGTHEN AND  
9 EXPAND THE".
  
- 10 Page 10, line 9, after "DEPARTMENT" insert "AND ADVISORY BODY".
  
- 11 Page 10, line 20, strike "AN ADEQUATE" and substitute "A".
  
- 12 Page 10, line 26, after "PROVIDE" insert "LOCALLY RESPONSIVE".
  
- 13 Page 10, line 27, strike "BARRIERS TO".
  
- 14 Page 11, line 1, strike "PROVIDERS AROUND LICENSING," and substitute  
15 "PROVIDER LICENSING AND REGULATIONS,".
  
- 16 Page 11, line 3, strike "CRITERIA, WITH FEEDBACK FROM" and substitute  
17 "CRITERIA AND PROCESSES, IN COLLABORATION WITH".
  
- 18 Page 11, line 5, strike "RESPONSIBILITY OF THE" and substitute  
19 "TREATMENT CAPACITY OR CLINICAL EXPERTISE OF THAT PROVIDER.".
  
- 20 Page 11, strike line 6.
  
- 21 Page 11, line 10, strike "SAFETY NET SYSTEM" and substitute  
22 "COMPREHENSIVE PROPOSAL AND THE FUNDING MODEL".
  
- 23 Page 12, line 18, strike "ROBUST".
  
- 24 Page 13, line 6, after "PROVIDERS" insert "THAT COLLECTIVELY OFFER A  
25 FULL CONTINUUM OF SERVICES".
  
- 26 Page 13, line 18, strike "IN".
  
- 27 Page 13, lines 18 and 19, strike "IN IMPLEMENTING AND ENSURING A" and  
28 substitute "ON THE BEHAVIORAL HEALTH".
