SB18-157 be amended as follows:

- 1 Amend printed bill, page 3, strike lines 15 through 19 and substitute:
- 2 "SECTION 2. In Colorado Revised Statutes, add article 5.1 to
- 3 title 28 as follows:

- 5 **ARTICLE 5.1**
- 6 **State Women Veterans Office**
- 7 **28-5.1-101. State women veterans office - women veterans".**
- 7 Page 3, line 22, strike "GOVERNOR'S OFFICE" and substitute "DEPARTMENT
- 8 OF MILITARY AND VETERANS AFFAIRS, REFERRED TO IN THIS SECTION AS
- 9 THE "DEPARTMENT",".
- 10 Page 3, line 27, strike "GOVERNOR'S OFFICE" and substitute
- 11 "DEPARTMENT".
- 12 Page 4, after line 3 insert:
- 13 "(3) THE SWVO AND THE STATE WOMEN VETERANS STEERING
- 14 COMMITTEE EXERCISE THEIR POWERS AND DUTIES UNDER THE
- 15 DEPARTMENT AS IF TRANSFERRED BY A TYPE 2 TRANSFER.".
- 16 Renumber succeeding subsections accordingly.
- 17 Page 5, strike lines 13 and 14 and substitute "ROOM FOR WOMEN
- 18 VETERANS WITHIN THE DEPARTMENT'S WEBSITE;".
- 19 Page 7, line 26, strike "24-37.7-101" and substitute "28-5.1-101".
- 20 Page 8, after line 9 insert:
- 21 "SECTION 4. In Colorado Revised Statutes, 24-1-127, add
- 22 (3)(h) as follows:
- 23 **24-1-127. Department of military and veterans affairs -**
- 24 **creation. (3) The department of military and veterans affairs shall consist**
- 25 **of the following divisions:**
- 26 (h) THE STATE WOMEN VETERANS OFFICE AND THE WOMEN
- 27 VETERANS STEERING COMMITTEE, ESTABLISHED PURSUANT TO SECTION
- 28 28-5.1-101, TRANSFERRED TO THE DEPARTMENT AS IF BY A TYPE 2
- 29 TRANSFER.".
- 30 Renumber succeeding section.
- 31 Strike "24-37.7-101." and substitute "28-5.1-101." on: Page 7, lines 20
- 32 and 24; and Page 8, line 8.
