Committee on Judiciary.HB17-1056 be amended as follows:

1 Amend printed bill, page 3, after line 10 insert:

2 "SECTION 2. In Colorado Revised Statutes, 18-18-432, amend
3 (2)(c) as follows:

4 **18-18-432. Drug offender public service and rehabilitation**
5 **program.** (2) (c) (I) If not already established pursuant to law, there may
6 be established in each judicial district in the state a useful public service
7 program under the direction of the chief judge of the judicial district. It
8 shall be The purpose of the useful public service program IS to identify
9 and seek the cooperation of governmental entities and political
10 subdivisions thereof and corporations organized not for profit or
11 charitable trusts, AS SPECIFIED IN SUBSECTION (2)(c)(II) OF THIS SECTION,
12 for the purpose of providing useful public service jobs; to interview and
13 assign persons who have been ordered by the court to perform useful
14 public service to suitable useful public service jobs; and to monitor
15 compliance or noncompliance of such persons in performing useful
16 public service assignments as specified in paragraph (a) of this subsection
17 ~~(2)~~ SUBSECTION (2)(a) OF THIS SECTION. NOTHING IN THIS SUBSECTION (2)
18 LIMITS THE AUTHORITY OF AN ENTITY THAT IS THE RECIPIENT OF
19 COMMUNITY OR USEFUL PUBLIC SERVICE TO ACCEPT OR REJECT SUCH
20 SERVICE, IN ITS SOLE DISCRETION.

21 (II) IN ADDITION TO GOVERNMENTAL ENTITIES AND POLITICAL
22 SUBDIVISIONS THEREOF, THE FOLLOWING ORGANIZATIONS ARE ELIGIBLE
23 TO PROVIDE COMMUNITY OR USEFUL PUBLIC SERVICE JOBS ESTABLISHED
24 UNDER THIS SECTION OR ANY OTHER PROVISION OF LAW SO LONG AS THEY
25 MEET ANY OTHER REQUIREMENT RELATED TO THE PROVISION OF THOSE
26 JOBS, AS ESTABLISHED BY THE ENTITY THAT IS THE RECIPIENT OF
27 COMMUNITY OR USEFUL PUBLIC SERVICE:

28 (A) A CHARITABLE TRUST OR OTHER ORGANIZATION THAT IS
29 EXEMPT FROM TAXATION UNDER SECTION 501 (c)(3) OF THE FEDERAL
30 "INTERNAL REVENUE CODE OF 1986", AS AMENDED;

31 (B) A CIVIC LEAGUE OR ORGANIZATION THAT IS EXEMPT FROM
32 TAXATION UNDER SECTION 501 (c)(4) OF THE FEDERAL "INTERNAL
33 REVENUE CODE OF 1986", AS AMENDED, AND THAT ALSO WOULD QUALIFY
34 AS A VETERANS' SERVICE ORGANIZATION AS DEFINED IN SECTION 501
35 (c)(19) OF THE FEDERAL "INTERNAL REVENUE CODE OF 1986", AS
36 AMENDED; AND

37 (C) A VETERANS' SERVICE ORGANIZATION THAT IS EXEMPT FROM



1 TAXATION UNDER SECTION 501 (c)(19) OF THE FEDERAL "INTERNAL
2 REVENUE CODE OF 1986", AS AMENDED."
