HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.HB16-1030 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and
2 substitute:

3 "SECTION 1. In Colorado Revised Statutes, 33-14.5-108.5,
4 amend (1) as follows:

5 **33-14.5-108.5. Crossing roads, highways, and railroad tracks.**

6 (1) The driver of an off-highway vehicle may directly cross a roadway,
7 including a state highway, at an at-grade crossing to continue using the
8 off-highway vehicle on the other side; except that a person shall not cross
9 a state highway within the jurisdiction of a municipality UNLESS THE
10 MUNICIPALITY AUTHORIZES A PERSON TO CROSS THE STATE HIGHWAY ON
11 AN OFF-HIGHWAY VEHICLE.

12 SECTION 2. In Colorado Revised Statutes, 33-14.5-110, amend
13 (1) as follows:

14 **33-14.5-110. Regulation by political subdivisions.**

15 (1) (a) EXCEPT AS PROVIDED IN PARAGRAPH (b) OF THIS SUBSECTION (1),
16 any county, city and county, city, or town acting by its governing body
17 may regulate the operation of off-highway vehicles on public lands,
18 waters, and property under its jurisdiction and on streets and highways
19 within its boundaries by resolution or ordinance of the governing body
20 and by giving appropriate notice thereof OF THE REGULATION if such THE
21 regulation is not inconsistent with the provisions of this article and the
22 rules and regulations promulgated pursuant thereto UNDER THIS ARTICLE.

23 (b) (I) NOTWITHSTANDING THE REQUIREMENT THAT ITS
24 ORDINANCE OR RESOLUTION NOT BE INCONSISTENT WITH THIS ARTICLE OR
25 A RULE PROMULGATED UNDER THIS ARTICLE, A COUNTY, CITY AND
26 COUNTY, CITY, OR TOWN MAY REQUIRE THE DRIVER WHO IS DRIVING AN
27 OFF-HIGHWAY VEHICLE ON A STREET, ROAD, OR HIGHWAY WITHIN THE
28 JURISDICTION OF THE COUNTY, CITY AND COUNTY, CITY, OR TOWN TO:

29 (A) HAVE A DRIVER'S LICENSE; OR

30 (B) CARRY LIABILITY INSURANCE.

31 (II) NOTWITHSTANDING SUBPARAGRAPH (I) OF THIS PARAGRAPH
32 (b), A COUNTY, CITY AND COUNTY, CITY, OR TOWN DOES NOT HAVE
33 AUTHORITY TO REQUIRE A DRIVER TO HAVE A DRIVER'S LICENSE OR CARRY
34 LIABILITY INSURANCE UNDER THE CIRCUMSTANCES DESCRIBED IN SECTION
35 33-14.5-108 (1) (a) TO (1) (i).

36 SECTION 3. **Safety clause.** The general assembly hereby finds,



1 determines, and declares that this act is necessary for the immediate
2 preservation of the public peace, health, and safety."
