SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.SB17-010 be amended as follows:

1 Amend printed bill, page 2, line 9, after "18-1.3-406 (2);" insert "ANY
2 CLASS 4, 5, OR 6 FELONY FOR WHICH THE FACTUAL BASIS INCLUDES AN ACT
3 OF DOMESTIC VIOLENCE, AS DEFINED IN SECTION 18-6-800.3 (1); ANY
4 CLASS 4, 5, OR 6 FELONY FOR A SEX OFFENSE DEFINED IN SECTION
5 18-1.3-1003 (5); CLASS 4 OR 5 FELONY CHILD ABUSE, AS DESCRIBED IN
6 SECTION 18-6-401; CLASS 4 OR 5 FELONY STALKING, AS DESCRIBED IN
7 SECTION 18-3-602; ANY CRIME AGAINST AN AT-RISK PERSON, AS DEFINED

11 Page 2, lines 15 and 16, strike "would be a felony ~~shall be adjudged~~" and
12 substitute "would be THE EQUIVALENT OF a felony ~~shall be adjudged~~ THAT
13 MAY BE USED FOR THE PURPOSES OF THIS SECTION".

14 Page 2, line 21, after "18-1.3-406 (2);" insert "ANY CLASS 4, 5, OR 6

25 AS DEFINED IN SECTION 18-6-800.3 (1); ANY CLASS 4, 5, OR 6 FELONY FOR
26 A SEX OFFENSE DEFINED IN SECTION 18-1.3-1003 (5); CLASS 4 OR 5 FELONY
27 CHILD ABUSE, AS DESCRIBED IN SECTION 18-6-401; CLASS 4 OR 5 FELONY
28 STALKING, AS DESCRIBED IN SECTION 18-3-602; ANY CRIME AGAINST AN
29 AT-RISK PERSON, AS DEFINED IN SECTION 18-6.5-102 (9); VEHICULAR

32 Page 3, line 19, strike "CLASS 4, 5, OR 6" and substitute "CLASS 4 OR 5".

33 Page 3, line 22, strike "18-1.3-406 (2)." and substitute "18-1.3-406 (2);
