SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.SB16-023 be amended as follows:

1 Amend printed bill, page 3, line 1, strike the first "The" and substitute
 2 "EXCEPT AS OTHERWISE PROVIDED IN PARAGRAPH (b) OF THIS SUBSECTION
 3 (15), the".

4 Page 3, line 2, strike "THROUGH THE".

5 Page 3, line 3, strike "2015-16 BUDGET YEAR".

6 Page 3, line 3, strike "pupil; AND" and substitute "pupil.".

7 Page 3, strike lines 4 through 25 and substitute:

8 "(b) IN EACH FISCAL YEAR IN WHICH THE AMOUNT OF REVENUE
 9 RETAINED BY THE STATE AND DEPOSITED IN THE PRESCHOOL THROUGH
 10 TWELFTH GRADE EDUCATION GENERAL FUND EXEMPT ACCOUNT CREATED
 11 IN SECTION 24-77-103.3 (3), C.R.S., EXCEEDS THE AMOUNT NECESSARY TO
 12 FULLY FUND THE STATE'S SHARE OF TOTAL PROGRAM FUNDING
 13 CALCULATED PURSUANT TO SECTIONS 22-54-104 (2) AND 22-54-106, THE
 14 LEGISLATIVE COUNCIL STAFF SHALL CALCULATE AN INCREASE IN THE
 15 FULL-DAY KINDERGARTEN FACTOR THAT EXPENDS AN AMOUNT EQUAL TO
 16 THE EXCESS AMOUNT REMAINING IN THE PRESCHOOL THROUGH TWELFTH
 17 GRADE EDUCATION GENERAL FUND EXEMPT ACCOUNT; EXCEPT THAT THE
 18 FULL-DAY KINDERGARTEN FACTOR SHALL NOT INCREASE TO FUND MORE
 19 THAN A FULL-DAY STUDENT.

20 **SECTION 2.** In Colorado Revised Statutes, **repeal** 22-54-131
 21 (6).".

22 Page 5, strike lines 2 and 3 and substitute "MONEY IN THE ACCOUNT TO
 23 FULLY FUND THE STATE'S SHARE OF TOTAL PROGRAM FUNDING
 24 CALCULATED PURSUANT TO SECTIONS 22-54-104 (2) AND 22-54-106,
 25 C.R.S.".

26 Page 5, strike lines 6 through 8 and substitute "THE GENERAL ASSEMBLY
 27 SHALL APPROPRIATE MONEY TO FUND KINDERGARTEN PUPILS AS FULL-DAY
 28 PUPILS BY INCREASING THE FULL-DAY KINDERGARTEN FACTOR AS
 29 PROVIDED IN SECTION 22-54-103 (15) (b), C.R.S.".
