HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.HB16-1105 be amended as follows:

1 Amend printed bill, page 2, after line 1 insert:

2 "SECTION 1. In Colorado Revised Statutes, 39-22-1001, amend
3 (7) as follows:

4 **39-22-1001. Limitation on the duration of voluntary**
5 **contribution programs - queue - notice - repeal.** (7) (a) No more than
6 ~~fifteen~~ SIXTEEN voluntary contributions ~~shall~~ ARE PERMITTED TO appear
7 on the Colorado income tax return form in any income tax year. If the
8 general assembly, acting by bill in any year, requires more voluntary
9 contributions to appear on the income tax return form than there are lines
10 available on the form, an existing voluntary contribution that is renewed
11 or continued ~~shall take~~ TAKES precedence and MUST be placed on the
12 form over a voluntary contribution that does not appear on the form. ~~and~~
13 ~~is not being renewed or continued.~~ Any voluntary contribution that does
14 not appear on the form and is not being renewed or continued but does
15 not take effect pursuant to this subsection (7) ~~shall~~ MUST be placed in the
16 queue created by subsection (8) of this section and ~~shall only become~~
17 BECOMES effective in any year in which there is a line available on the
18 income tax return form, as specified in subsection (8) of this section.

19 (b) (I) NOTWITHSTANDING ANY PROVISION OF THIS SUBSECTION
20 (7) TO THE CONTRARY, FOR THE PURPOSES OF INCLUDING THE
21 MAKE-A-WISH FOUNDATION OF COLORADO VOLUNTARY CONTRIBUTION
22 FUND ON THE INCOME TAX RETURN FORMS PURSUANT TO SECTION
23 39-22-3602 AND ASSESSING WHETHER SAID FUND RECEIVES THE REQUISITE
24 AMOUNT OF CONTRIBUTIONS UNDER PARAGRAPH (a) OF SUBSECTION (5) OF
25 THIS SECTION, THE DEPARTMENT SHALL TREAT SAID FUND AS IF IT IS BEING
26 CONTINUED.

27 (II) THIS PARAGRAPH (b) IS REPEALED, EFFECTIVE JULY 1, 2022."

28 Renumber succeeding sections accordingly.

29 Page 2, line 5, strike "(1)" and strike "~~commencing on or after January 1,~~"
30 and substitute "commencing on or after January 1,".

31 Page 2, strike lines 6 through 17 and substitute "~~2012, but prior to January~~
32 ~~1, 2017~~ 2016, BUT PRIOR TO JANUARY 1, 2021,".

33 Page 2, line 19, strike "CONTAINS" and substitute "MUST CONTAIN".

- 2 Page 3, strike lines 1 through 7.
- 3 Page 3, strike lines 11 through 15 and substitute "January 1, 2018 2022,
- 4 unless the".
