HB19-1212 be amended as follows:

- 1 Amend reengrossed bill, page 18, strike line 26 and substitute:
  - 2 "(d) THE ISSUANCE AND RENEWAL OF APPRENTICE CREDENTIALS;
  - 3 AND".
- 4 Reletter succeeding paragraph accordingly.
- 5 Page 19, line 19, strike "STATE UPON" and substitute "STATE".
- 6 Page 19, strike lines 20 through 25 and substitute "THE DIRECTOR, AFTER  
7 HOLDING A".
- 8 Page 22, line 3, strike "SIGNIFICANTLY".
- 9 Page 32, strike lines 2 through 4 and substitute:

  - 17 EDUCATIONAL REQUIREMENTS, SPECIFIC DUTIES, AND ANY OTHER
  - 18 NECESSARY COMPONENTS RELATED TO APPRENTICES;"
- 19 Page 32, line 22, strike "INPUT".
- 20 Page 32, strike line 23 and substitute "INFORMATION AND FEEDBACK FROM  
21 THE STAKEHOLDERS".
- 22 Page 32, strike lines 24 through 27.
- 23 Strike pages 33 through 35.
- 24 Page 36, strike lines 1 through 5.
- 25 Renumber succeeding C.R.S. section accordingly.
- 26 Page 52, strike line 24 and substitute:
  - 27 "(d) THE ISSUANCE AND RENEWAL OF APPRENTICE CREDENTIALS;
  - 28 AND".

- 1 Reletter succeeding paragraph accordingly.
- 2 Page 53, line 17, strike "STATE UPON" and substitute "STATE."
- 3 Page 53, strike lines 18 through 23 and substitute "THE DIRECTOR, AFTER  
4 HOLDING A".
- 5 Page 56, line 1, strike "SIGNIFICANTLY".
- 6 Page 65, strike line 27.
- 7 Page 66, strike lines 1 and 2 and substitute:  
8 **"12-10-1014. Stakeholder meetings - topics - frequency. (1)**  
9 THE DIVISION SHALL ESTABLISH A STAKEHOLDER PROCESS WITH REGULAR  
10 MEETINGS, NO LESS FREQUENTLY THAN EVERY THREE MONTHS. THE

- 18 Page 66, strike line 21 and substitute "INFORMATION AND FEEDBACK FROM  
19 THE STAKEHOLDERS."
- 20 Page 66, strike lines 22 through 27.
- 21 Strike pages 67 through 69.
- 22 Page 70, strike lines 1 through 3.
- 23 Renumber succeeding C.R.S. section accordingly.
