SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB17-103 be amended as follows:

1 Amend printed bill, page 5, line 12, strike "THE" and substitute "IF A
2 SCHOOL DISTRICT INCLUDES A DISTRICT PUBLIC SCHOOL THAT IS
3 OPERATING UNDER A PRIORITY IMPROVEMENT OR TURNAROUND PLAN AND
4 ENROLLS STUDENTS IN KINDERGARTEN OR ANY OF GRADES ONE THROUGH
5 THREE, THE".

6 Page 5, line 13, strike "A SCHOOL DISTRICT MUST, AT A MINIMUM,
7 INCLUDE" and substitute "THE SCHOOL DISTRICT SHALL INCLUDE, BUT
8 SHALL NOT BE LIMITED TO,".

9 Page 5, strike lines 16 through 19 and substitute:
10 "(4) AN EARLY CHILDHOOD LEARNING NEEDS ASSESSMENT MUST
11 DETERMINE THE".

12 Page 6, line 11, strike "OPPORTUNITIES" and substitute "OPPORTUNITIES,
13 INCLUDING OPPORTUNITIES FOR EDUCATOR COLLABORATION,".

14 Page 7, line 10, strike "THE" and substitute "IF A SCHOOL DISTRICT
15 INCLUDES A DISTRICT PUBLIC SCHOOL THAT IS OPERATING UNDER A
16 PRIORITY IMPROVEMENT OR TURNAROUND PLAN AND ENROLLS STUDENTS
17 IN KINDERGARTEN OR ANY OF GRADES ONE THROUGH THREE, THE".

18 Page 7, line 11, strike "A SCHOOL DISTRICT MUST, AT A MINIMUM,
19 INCLUDE" and substitute "THE SCHOOL DISTRICT SHALL INCLUDE, BUT
20 SHALL NOT BE LIMITED TO,".

21 Page 8, line 1, strike "MUST, AT A MINIMUM, INCLUDE" and substitute
22 "SHALL INCLUDE, BUT SHALL NOT BE LIMITED TO,".

23 Page 8, strike lines 3 through 7 and substitute:
24 "(4.5) AN EARLY CHILDHOOD LEARNING NEEDS ASSESSMENT MUST
25 DETERMINE THE EXTENT TO WHICH:".

26 Page 9, line 5, strike "OPPORTUNITIES" and substitute "OPPORTUNITIES,
27 INCLUDING OPPORTUNITIES FOR EDUCATOR COLLABORATION,".

28 Page 10, line 3, strike "MUST, AT A MINIMUM, INCLUDE" and substitute
29 "SHALL INCLUDE, BUT SHALL NOT BE LIMITED TO,".
