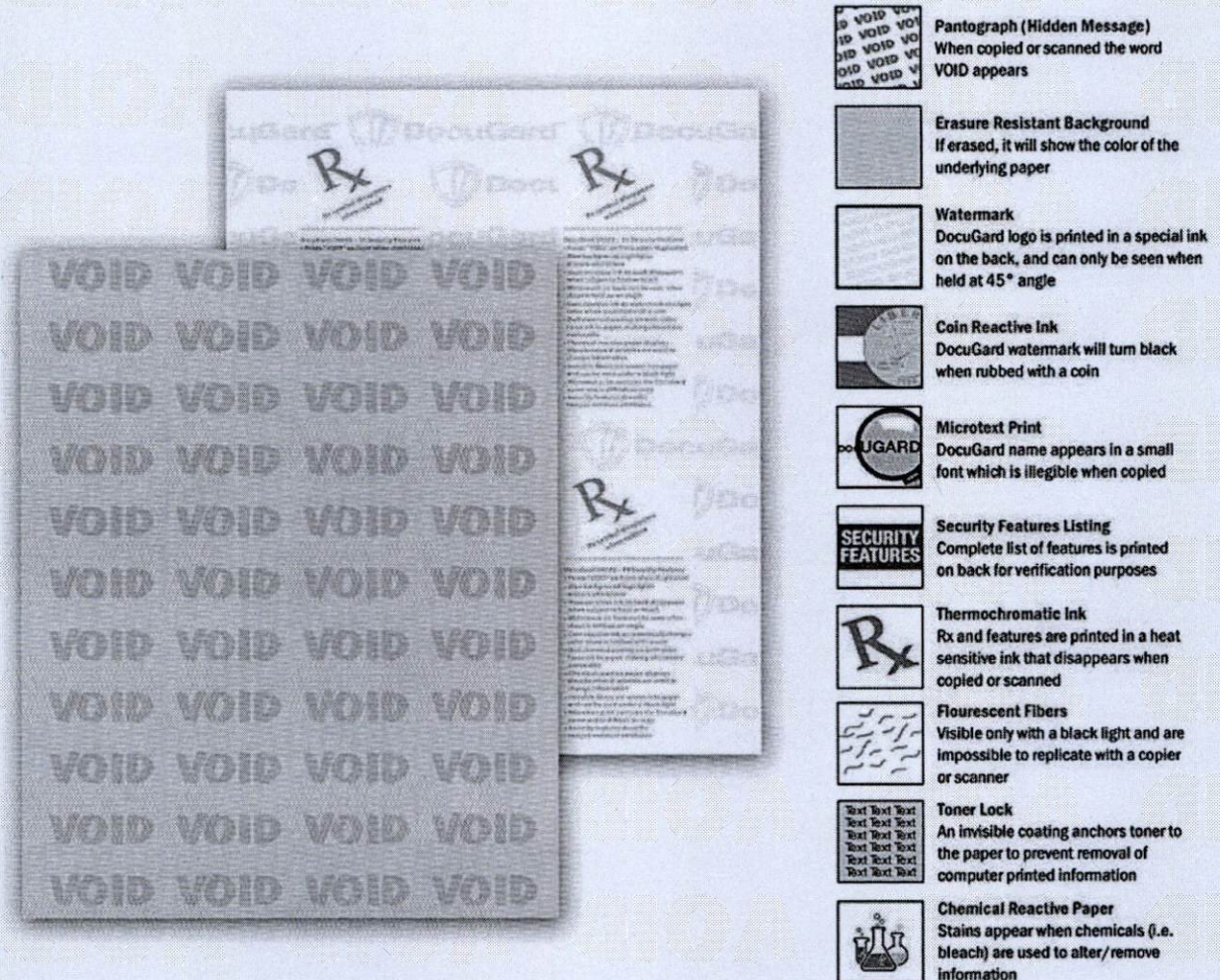


This is CMS (Centers for Medicaid and Medicare Services) approved paper.

It includes 10 security features meant to prevent fraud:



Pantograph (Hidden Message)
When copied or scanned the word VOID appears



Erasure Resistant Background
If erased, it will show the color of the underlying paper



Watermark
DocuGard logo is printed in a special ink on the back, and can only be seen when held at 45° angle



Coin Reactive Ink
DocuGard watermark will turn black when rubbed with a coin



Microtext Print
DocuGard name appears in a small font which is illegible when copied



Security Features Listing
Complete list of features is printed on back for verification purposes



Thermo-chromatic Ink
Rx and features are printed in a heat sensitive ink that disappears when copied or scanned



Fluorescent Fibers
Visible only with a black light and are impossible to replicate with a copier or scanner



Toner Lock
An invisible coating anchors toner to the paper to prevent removal of computer printed information



Chemical Reactive Paper
Stains appear when chemicals (i.e. bleach) are used to alter/remove information
